I have the honour to report that today i.e. 27/08/2025 @ 1:30 pm, while conducting random frisking and checking by joint operation team of Mao-PS Police team. SOT-Senapati, along with A/109 Bn of CRPF and B-Coy, 16 AR at Martyrs Park which is about 2 km South of Mao-PS, one passenger Winger (white colour) bearing Regd. No. AR01L-5938 coming from Imphal side towards Dimapur along NH-2 was stopped by the joint team for frisking and checking. While checking, one person namely Md. Yunush Khan (31) S/o Md. Shahbuddin of Irong Chesaba Mayai Leikai, P.S.- Mayang Imphal, Thoubal District, Manipur was found suspicious and admitted to have possessed some illegal W.Y. (Amphetamine) Tablets tied to his both thigh with anklets. ADM/MAO was intimated and a request was made for authorizing for carrying out formalities. Accordingly ADM/MAO Shri. Rang David Kung (Executive Magistrate), Song Song himself arrived for doing the necessary procedures. The person was checked in the presence

of Shri. Rang David Kung, A/DM Mao, Mao Police personnel, SGT Senapati, A/100 Bn of CRPF, B. Coy, 18 AR, and driver of the wing as witness. On searching his body, 02 (Ninety-two) plastic packets of suspected W Y (Amphetamine) Tablets were discovered. The 02 (Ninety-two) plastic packets of suspected W Y (Amphetamine) Tablets were weighed by using weighing machine with video coverage as per BNSS in presence of the Executive Magistrate and driver of the wing as witness.
