

Sir,

I have the honour to report that today i.e. 29/08/2025 at 1.00 pm, while conducting random frisking and checking by the team of Mao-PS at Mao-Police Check Post along NH-2 which is about 1 km North West of Mao-PS. During frisking and checking one passenger Winger (white colour) bearing Regd. No. MN05D-0001 coming from Senapati side towards Dimapur was stopped by the team for checking. While checking the vehicle, two women were found very suspicious, so they were brought to the PS for further checking by lady police in the presence of Executive Magistrate. ADM/MAO was intimated and a request was made for authorizing for carrying out formalities. Accordingly ADM/MAO Shri. Rang David Kung (Executive Magistrate), Song Song himself arrived for doing the necessary procedures. The two women were checked in the presence of Shri. Rang David Kung, ADM/Mao, Mao Police personnel and driver of the winger as witnesses. On checking, 8 (eight) soap cases suspected to be brown sugar were detected from the hand bag of H. Khune (45) W/o. B. Daniel of Tunggam Afii Village, and she admitted to have possessed the said soap cases. The second person identified herself as B. Dane (42) W/o N. Tennyson of Tunggam

Alfi Village, PS-Tungjoy, Senapati District, Manipur A/P. TNK Village, Senapati and she stated that she was going together with H. Khune. The 8 (eight) soap cases suspected to be brown sugar were weighed by using weighing machine with video coverage as per BNSS in presence of the Executive Magistrate and driver of the winger as witnesses. The consignment was found to be weighing 113 grams including the weight of plastic packets. Further, the following items were also recovered from their possession:-

- 1) One ladies hand bag purple in colour of H. Khune.
- 2) One Ladies hand bag black in colour of B. Dane.
- 3) One Redmi Mobile Phone, Model- A92 bearing IMEI1- 860563055525295, IMEI2- 860563055525303 along with Airtel SIM bearing Mobile No.7085117630 belong to H. Khune.
- 4) One Samsung keypad phone, Model-GT-E1200Y bearing IMEI1-354739/89/659262/8 along with Airtel SIM card bearing mobile No. 8798771471 belong to B. Dane.

Hence, the above mentioned suspected brown sugar along with recovered items were seized by preparing a seizure memo at 2.30 pm and 2:35 pm and also arrested the accused persons at 2.40 pm and 2:45 pm by observing formalities at the spot.

Therefore, the seized items along with the arrested accused person are handed over to you for taking further necessary legal action please.
