Sir,

I have the honour to report that today i.e. 10/10/2025 at 6:20 am, while conducting random frisking and checking by the team of Mao-PS and A-109 CRPF at Mao-Police Check Post along NH-2 which is about 1 km North West of Mao-PS. During frisking and checking one KIA Sonet (black colour) bearing Regd. No. AS02AM 5095 coming from Senapati side towards Dimapur was stopped by the team for checking.

While checking the vehicle, two men were found in a suspicious manner, on interrogation they admitted to possess illegal drugs. On confirming the presence of soap cases suspected to be brown sugar, ADM/MAO was intimated and a request was made for authorizing for carrying out formalities. Accordingly ADM/MAO Shri. Rang David Kung (Executive Magistrate), Song Song himself arrived for doing the necessary procedures On his arrival, the two persons identified themselves as 1) Abu Hanifa (24) s/o

Habibur Rahman of 151 VTC Bajia Gaon, PO Bajia Gaon, Samgurl Sub-Division, Nagaon District, Assam 2) I.I.F - 2) Safiqul Islam (38) s/o Hajrat Ali of 445 Gerua Ati, Nagaon, Assam and later produced 12 soap cases concealed inside air filter box and 4 (four) soap cases from gear box total to be 16 Soap cases of suspected brown sugar.

The 16 (sixteen) soap cases suspected to be brown sugar were weighed in presence of executive Magistrate and witnesses by using weighing machine with video coverage as per BNSS in presence of the Executive Magistrate. The consignment was found to be weighing 157 grams including the weight of plastic packets (excluding the weight of soap cases cover). Further, the following items were also recovered from their possession:-

- 1) One KIA Sonet (black colour) bearing Regd. No. AS02AM 5095 along with key.
- 2) One brown wallet of Abu Hanifa containing
 - a) One Pan Card bearing no. BLNPH5496J
 - b) One Suryoday ATM card bearing no 6080390000900469
 - c) one hundred rupees
- 3) One Mortorola phone bearing IMEI -1 357726271584459/02, IMEI -2- 35772627154467/02 along with one airtel sim -9387968356 and one Jio Sim 9864333191 of Abu Hanifa.
- 4) One Aadhaar card of Safiqul Islam bearing 284848459886.
- 5) One Nokia black and white phone bearing IMEI No.-350960973051437 along with one Airtel sim - 9633828870 of Safiqul Islam.

Hence, the above mentioned suspected brown sugar along with recovered items were formally seized by preparing a Seizure Memo at 8:40 am also arrested the accused persons at 9:00 am by observing formalities by S.I Pavei Alexius Pou of Mao PS in presence of Executive Magistrate and witness.

Therefore, the seized items along with the arrested accused persons are brought to Police Station for taking further necessary legal action.


