I have the honour to report that at around 8.30 pm of 30/10/2025 to 12.30 am of 31/10/2025, my Motorbike Royal Enfield Hunter 350, Rebel Red in colour bearing regn. No.MN04G5813, Chassis No. ME3J3D5FCP1011766, Engine No. J3A5FCP1082483 and model-2023 which recorded in the name of Sanasam Naoba Singh S/o Sanasam Priyokumar Singh of Landing Cherapur, was found stolen away by unknown person while it was parked inside the play ground near Thoubal Sabaltongba Laikon under proper lock and could not be found till date despite numerous efforts to locate it.
