With due respect, I the undersigned have the honour to report an incident of theft which occurred yesterday i.e. 03/11/2025 at around 11.30 pm at Sangaiyumpham Prt-II, Mairenkun Tentha Maya, Thoubal. That, the below mentioned articles/items including some cash amounting to Rs. 50,400/- only, Gold (1and half sans) amounting to Rs. 29000/- only and Grocery items worth Rs. 25,000/- only which were kept inside my Grocery Shop were found stolen away by unknown person(s) by entering inside after breaking down the back side wall of the said shop and was unable to identify or trace out anyone involved in the said incident.
