Subject : Report.

Sir,

I have the honour to report that, today i.e. 06/11/2025 at about 10:30 am, I left my home for a private matter in my locality after properly closed and locked my entrance gate, all doors and windows. When, I returned home on the same day at about 1:20 pm, suspiciously, one unknown person came out from backside of my house. On checking, my house was found ransacked. On further checking, the following items that were kept inside my wooden Almirah were found stolen away by the above unknown person who entered inside after breaking the backside doors of my house by taking the advantage of the lone house. Immediately, the unknown person was chased and caught red handed at the paddy field of Co-Palli by the localities. On further verification, the unknown person identified himself as Sambanduram Jeoroboss @ Momo Singh (21) yrs S/o S. Jadumani Singh of Wangjing Sorokhaibam Leikai and detained him by local people.
