11. First Information contents: Today i.e. 12/11/2025 at 10:50 am, received an information that on the same day at about 10:45 am, one Diesel Auto Rickshaw bearing regn. no. MN04D6601 proceeding from Khangabok village towards Khangabok Bazar side along ODR Khangabok met a road traffic accident with one motorcycle Royal Enfield bearing regn. no. MN04G9869 which was coming in opposite direction at Khangabok Khullakpam Leikai opposite Charu Mandop due to rash or negligent driving/riding on the part of both unknown driver/rider of the said Diesel Auto Rickshaw and motorcycle Royal Enfield. As a result, unknown diver of the Diesel Auto Rickshaw bearing regn. no. MN04D6601 and unknown rider including one unknown pillion of the motorcycle Royal Enfield bearing regn. no. MN04G9869 sustained severe injuries and evacuated to the hospital for medical treatment. Both vehicles were also partly damaged. Hence the case.
