MN06SG1664 proceeding from District Hospital, Thoubal towards NH102 collided with one Honda Activa bearing regn. no. MN01AN2755 which was coming from Wangjing towards Thoubal side at Khangabok in front of District Hospital, Thoubal Khangabok along NH102 due to rash or negligent riding on the part of both unknown riders. As a result, riders of both vehicles sustained severe injuries and evacuated to the District Hospital, Thoubal for medical treatment. Both vehicles were also partly damaged. Hence the case.
