

Today i.e. 24/11/2025 at 2:40 pm, received a reliable information that on the same day at @ 2:30 pm, one Motor Vehicle i.e. Dio B/Regd. No. MN01AQ1437 Candy Jazzy Blue in colour coming from Shikhong Bazar side towards Yairipok Bazar ridden by an unknown rider had dashed to one Tata Ace Magic vehicle B/Regd. No. MN01X-8992 White in colour which come from opposite direction at Ukhongshang Lamkhai area due to rash or negligent riding on the part of unknown rider of Dio. As a result of which the unknown rider received injury and evacuated to Hospital for medical treatment. And both the vehicles were partly damaged due to the incident.
