Sir,

Sir, I would like to inform you that yesterday i.e. on 16.10.2025 at about 9 pm while I had parked my car in front of Keishamthong High School and went to purchase some grocery item from Enao grocery shop (Elangbam Leikai), Ronaldjit Oinam and his sister came and scratch my car with their 2 wheeler. A person saw and asked them to ride the vehicle properly due to which an argument took place between them. After purchasing my grocery items and came to car, I saw them arguing and went there to stop them and also told them not to argue. I had also told Ronaldjit to ride carefully. Thereafter, Ronald and his 6 persons came and surrounded me and repeatedly assaulted me by kicking me on my head, neck and other body parts leaving with no chance to escape from their clutch. At the same time one of the persons who can be identified by me shown to me had also attempted to hit on my head with a brick. Some elders intervene and saved my life.

Therefore, I was taken to the hospital. Therefore, I request you to take strict action against Ronaldjit Oinam and 6 persons for assaulting me with an object of killing me without rhyme and reason.

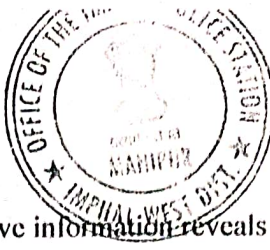
