

That, on 17/10/2024 at about 12:30 PM I received a phone call from one Yumnam Clinton, (25), who was a semester. law student of the same institution. During the conversation, Clinton told me to meet him at around 03:30 PM after the completion of our exam. When I asked him the reason for such a meeting, he did not disclose anything and simply said that it was something important. I informed him that after the examination, I would be returning home and that if he wished to talk, I would come along with a friend to discuss the matter. However, Clinton insisted that I come alone and refused to state the purpose of the meeting. After the exam was over, at around 3:05 PM, I noticed Clinton, Nikesha. Bidyanda @ Kangleipak Hulk, and one unknown person waiting for me outside the college premises. They called me over, and upon approaching them, Clinton forcefully snatched away my mobile phone without my consent. We had a brief conversation lasting about five minutes, during which Clinton and his associates spoke in an aggressive manner. I then told them that I needed to go to the toilet. However, while I was returning from the toilet, Clinton suddenly punched me on my face without any provocation, following which he slapped and kicked me several times. Thereafter, I was forcibly taken to the Union Room of the College, where I was again beaten up using a stick. During this assault, I was forced to do 100 squats as a form of humiliation while Clinton and his associates filmed the entire act on a mobile camera. Despite my repeated pleas for mercy and my denial of any wrongdoing, they continued to physically and mentally torture me. Subsequently, I was taken to the Headquarters of the All Manipur Students' Union (AMSU) located within the DM College Campus. At the said location, Anish (25 years), a resident of Sangaiyumpham, Imphal East District, Manipur, was also present along with Clinton, Nikesha, and Bidyanda @ Kangleipak Hulk. There, I was again caught hold of by my hands and legs by Clinton's group members, and Clinton brutally assaulted me with a wooden log, striking several parts of my body. I was also slapped numerous times, my hair was pulled violently, and I was kicked repeatedly by the said individuals. Throughout the physical assault, they verbally abused me with filthy language and forced me to tender an apology for acts that I had never committed, while continuing to record the entire incident on their mobile phones. I was humiliated, threatened, and made to feel helpless and degraded in the presence of several other persons.

Further, they instructed me that I would have to return to the AMSU Headquarters on the following day, i.e., 18/10/2024, at around 1:00 PM, along with one Sweety, another student of LMS Law College, to make another public apology before them. However, during this time, a team from Imphal Police Station arrived at the AMSU Headquarters upon receiving information about the incident. The police personnel rescued me from the custody of the said individuals and immediately took me to the Regional Institute of Medical Sciences (RIMS), Lamphel, for medical examination and necessary treatment. Due to the unprovoked, inhuman, and merciless physical assault, coupled with the mental harassment and public humiliation inflicted upon me, I have sustained severe bodily pain, mental trauma, and emotional distress. I am unable to comprehend why such false accusations were made against me and why I was subjected to such a barbaric act within an educational institution. The entire act of wrongful restraint, criminal intimidation, and physical assault has deeply affected my sense of security and dignity.

Hence, I pray that necessary legal action may kindly be initiated against the culprits, namely Yumnam Clinton, Nikesha, Bidyanda @ Kangleipak Hulk, Anish of Sangaiyumpham, and the unknown associate, for their unlawful acts of physical assault, wrongful confinement, criminal intimidation, and intentional humiliation.
