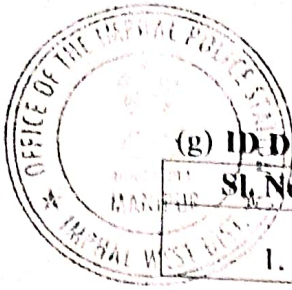

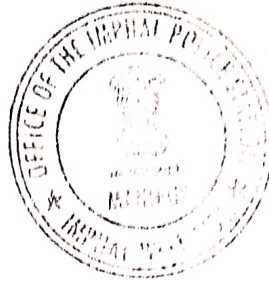

Sir,

I have the honour to report that today, i.e., 16/10/2024, at around 10:30 AM, I dropped my wife namely Singamayum Tajmina (22 years), resident of Kshetri Bengoon Mayai Leikai, Imphal East District, Manipur, at the Department of Anthropology, D.M. University, for appearing in her examination. However, at around 1:30 PM, I received a phone call from my sister-in-law namely SM Rafiya (36) stating that one of her friends informed her that Tajmina had not appeared for the examination. Being surprised and concerned, I immediately went to D.M. University to enquire about her whereabouts. One of her friends informed me that Tajmina might have been abducted/kidnapped from the University campus. It is highly suspected that the crime might have been committed by one Sharif Khulakpam (32 years), son of Ahamad Ali @ Hamdan of Yairipok Bamon Leikai, Thoubal District, Manipur, who is her friend. He and his family member had been continuously harassing my wife through phone calls and messages, and had also threatened her repeatedly in the past.

Hence, I request that strict action may kindly be taken according to law, and she may kindly be traced out at the earliest to ensure her safety.
