It is therefore, requested kindly to recover the said stolen scooter and take up necessary legal action against the unknown culprit(s) as per law.

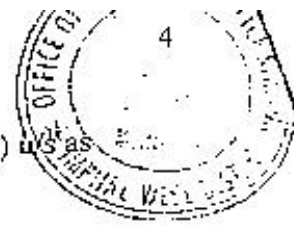

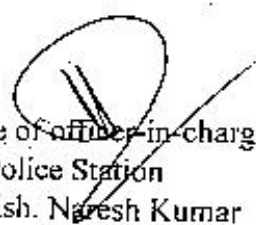
