

I have the honour to state the following few lines for your kind perusal and further necessary action to register a regular FIR at the earliest. The brief fact of the case is that on 29/06/2025 the complainant namely Moirangthem Yusembo Mainst (200). Yuremba Meitei (26) yrs, S/o M, Helem Meitei, Lairen Sajik Makha Leikui, Imphal West District, Manipur reported to OC-Implication. to OC-Imphal PS stating that one person namely Sylvia Thingujam, (42) W/o Thokehom Imocha Singh a resident of Lamboi Whomen Sharing that one person namely Sylvia Thingujam, (42) W/o Thokehom Imocha Singh a resident of Lamboi Khongnangkhong, Samushang, Imphal West District, Manipur, now serving as a Laboratory assistant at Rural Engineering Development, 4th floor, Secured Office Complex, A.J. Linc, North A.O.C. Imphal. That on 05/04/2021 she approached him and his colleagues namely i) Ngangbam Voken Singh S/o. Ngangbam Lar Singh of Khurkhul Makha Leikai, ii) Ngangham Kameshor Singh S/o Ngangbam Lar Singh of Khurkhul Makha Leikei, iii) Ngangbam Pholojao Singh S/o Ngangbam Lar Singh of Khurkhul Makha Leikai and iv) Thingujam Romesh Singh S/o Th. Rajen Singh of Khurkhul Mukhu Leikai to offer a job in Rural Engineering Dept. as a post of Technical Assistant and Road Mohori. On 05/05/2021, she mortgaged one ATM Card and Pension Book of her cousin sister and took a loan of Rs. 33,00,000/- (Rupees thirty-three laklis) from them with an agreed interest of 3% per month. However, she failed to repay the said amount till date. Further, she had collected a sum of Rs. 13,00,000 (Rupees thirteen takks) only from 1) Rs. 600,000/- (Rupees six lakks) from Ngangbam Kameshor, 2) Rs. 300,000/- (Rupees three lakhs) from Moirangthem Yuremba Meitel, and 3) Rs. 500,000/- (Rupees five lakhs) from Thingujam Romesh Singh for offering the job as a post of Technical Assistant and Road Mohori at Rural Engineering Development, 4th floor, Secured Office Complex, A.I. Line, North A.O.C. Imphal. Later, on 31/10/2021, she handed them job appointment letters, dated 10th Sept. 2021, allegedly appointing them as Tech. Assistant and Road Mohoris of Rural Engineering Department (RED)/MSRRDA, Govt. of Manipur. . Upon verification, it was revealed that the said appointment letters were furged and fake. Despite several visits to her residence to request a refund, her husband and the alleged accused person threatened the complainant with dire consequences when asked to return the money and told him never visit to her house again for this matter in future. Hence the enquiry, it refers to GD Entry No. 17/IPS/2023 dtd. 29/06/2025. During the enquiry, on 02/07/2025, the alleged accused person was summon to appear at Imphal PS. Accordingly the alleged accused person namely Sylvia Thingujam, (42) W/o Thokehom Imocha Singh a resident of Lamboi Khongnangkhong, Samushang, Imphal West District, Manipur, now serving as a Leboratory assistant at Rural Engineering Development, 4th floor, Secured Office Complex, A.J. Line, North A.O.C. Imphal was appeared at Imphal PS and she had admitted to committed the offence that she had collected a sum of Rs.28,00000/- (Rupees twenty eight takks) only from the complainant and his other four colleagues to offer a job in Rural Engineering Dept. 4th floor, Secured Office Complex, A.J. Line, North A.O.C. Imphal as a post of Technical Assistant and Road Mohori. Further, on 31/10/2021, she had handed a fake job appointment letters, vide Govt. orders No.7/15/2012-RD(MC)/C dated 10th Sept. 2021, allegedly appointing them as Tech. Assistant and Road Mohoris of Rural Engineering Department (RED)/MSRRDA, Govt. of Manipur, Further, the job appointment letter is required to be verified to determine whether it is genuine or forged/fake. It is also revealed that the accused person was collecting a large sum of money by offering take appointment orders, committing fraud and chenting for her own benefit.

In view of the above facts and circumstances, you are therefore requested to kindly register a regular case so that the investigation of the case can be performed smoothly to find out the real facts of the case at the earliest,
