

Subject : Report.

Sir,

With due regards, I beg to state that today i.e. 27/06/2025 at about 07:10 a.m. received a reliable information that some unknown armed miscreants have stored and hidden some arms, ammunitions and explosives at the Khongjom Langathel Hangoipat hill for using offensive act against State Security Forces and CAPF.

On receipt of the information, Joint team of Commando Unit, Thoubal led by Inspt. K. Nitaranjan Singh, OC/CDO-TBL under the command of Shri. Hijam Devendra Singh, Addl. SP(Ops)/TBL and under the overall supervision of Shri. Manoj Prabhakar M, IPS, SP/TBL have rushed to the spot immediately and launched a massive operation at 08:00 a.m. On searching and found the undernoted articles i.e.

- 1) 1 (one) No. of 7.62 SLR bearing body No. 16254134,
- 2) 1 (one) No. of .303 Rifle bearing body No. GRI 1947 MM,
- 3) 1 (one) No. of Pump action short gun marked as AHT,
- 4) 1 (one) No. of 36 HE Hand Grenade,
- 5) 136 (one hundred and thirty six) Nos. of .303 ammunition,
- 6) 125 (one hundred and twenty five) Nos. of MMOC Carbine ammunition,
- 7) 21 (twenty one) Nos. of SLR ammunition,
- 8) 46 (forty six) Nos. of AK ammunition,
- 9) 19 (nineteen) Nos. of INSAS ammunition,
- 10) 17 (seventeen) Nos. of DBBL cartridge,
- 11) 2 (two) Nos. of .303 Rifle magazine,
- 12) 1 (one) No. of MMOC Carbine magazine,
- 13) 1 (one) No. of SLR magazine,
- 14) 8 (eight) Nos. of charger clip and
- 15) 3 (three) Nos. of .303 bandolier

from the spot at 09:20 a.m. Hence the above noted articles were seized at DHQ Thoubal at 10:08 a.m. by observing formalities. The massive searched Operation was conducted from 08:00 a.m. to 09:20 a.m. on the same day.

It may be mentioned that all the necessary formalities under BNSS i.e. preparation of seizure memo by taking videography during seizure could not be done at the spot as information was received from intelligence sources that some unknown miscreants may attack or some organised public mob may be initiated to forcefully and snatch the recovered arms ammunitions.

So, it is therefore, handed over the seized articles to you for your kind consideration and further necessary action.
