Sir,

With due regards, I beg to state that today i.e. 04/11/2025 at about 04:00 a.m. received a reliable information that some unknown armed miscreants have stored and hidden some arms, ammunitions and explosives at the foot hill of Tentha Tuwaband for using offensive act against State Security Forces and CAPF.

On receipt of the information, joint team of Commando Unit, Thoubal led by Divya, IPS, i/c Addl. SP (L&O), Thoubal and Inspt. K. Nitaranjan Singh, OC/CDO-TBL and under the overall supervision of Shri. Manoj Prabhakar M, IPS, Superintendent of Police, Thoubal and a column of 33 AR have rushed to the spot immediately and launched a massive operation at 05:40 a.m. On searching and found the undernoted articles i.e.

- 1) 1 (one) No. of M 16 Rifle narked as COLTS PATENT FIRE ARMS,
- 2) 1 (one) No. of SBBL PAG (Repeater) marked as PX-701-AS,
- 3) 1 (one) No. of .22 Rifle along with magazine,
- 4) 1(one) No. of 9 mm Pistol along with magazine,
- 5) 4 (four) Nos. of 9 mm Pistol along with magazine marked as i) A3271, ii) A7692, iii) K4649 & iv) K4892,
- 6) 4 (four) Nos. of 9 mm ammunition,
- 7) 2 (two) Nos. of .22 ammunition,
- 8) 4 (four) Nos. of 12 bore cartridge and
- 9) 2 (two) Nos. of Gren No. 80 MK I Grenade

from the spot and seized at 06:25 a.m. by observing formalities. The massive searched Operation was conducted from 05:40 a.m. to 07:00 a.m. on the same day.
