On the above cited subject, I have the honor to submit herewith the FIR that on 30th October, 2025 at around 9:30 PM four of us (Monsang Students Leaders) namely,

1. Gedion Kiirii, President, STS of Japhou Village.
2. Wanglar Phillip, General Secretary, STS of Japhou Village.
3. Ts. Hollyson of Liwa Khullen Village.
4. Th. Moni of Liwa Khullen Village.

came from Kakching Lamkhai leaving for home, Chandel, we stop our vehicle nearby Bijoypur towards Pallel side for Nature Calls (No.1). Soon, we stop for that nature call, the said Miscreant (Unknown Persons) more than 6 (six), 7 (seven) persons immediately approached us by one Activa and E-Auto and started attacking us without any exchange of words and attempted to kill us by assaulting brutally. At that immediate attacking, 2(Two) of us namely

1. Gedion Kiirii, President STS of Japhou Village, Chandel.
2. Ts. Hollyson, Senior Leader of STS of Liwa Khullen Village, Chandel.

were brutally beaten. Mr. Gedion Kiirii was seriously injured in the forehead with full of blood and Mr. Ts. Hollyson was also seriously injured on the face with blood. Soon after the brutal attack, they immediately run and escaped towards the Pallel side. We were left on the spot. Then, after that we managed to rush to nearest PHC at Komlathabi for First Aid.

Therefore, your good office is reported as law and order enforcing agency to find out those miscreants (unknown persons) at the earliest time and seeking for justice at the earliest time according to Monsang Naga Customs.


