I have the honour to report that today i.e. 02/11/2025 at around 0500 hrs. received a reliable information about the presence of some member of banned outfit UG organization KCP (Taibanganba) at Kakching Lamdong area. On receiving the information, CDO teams rushed to the said area and conducted frisking and checking at Kakching Lamdong area near Bobon brick field by establishing a mobile check point. During the course of Frisking & checking one suspected individual matching with the input received was detained from one Passenger Auto Riskshaw.

On examination, the detainee could be identified as Meisnam Langamba Meitei (24yrs) S/o. Meisnam Inakhunba Meitei of Laingoubi Mayai Leikai under the Jurisdiction of Kumbi PS, District-Bishnupur.

On basic questioning, the individual disclosed that he is an active member of the banned organization KCP (Taibanganba) and joined the banned organization in August, 2023 through S/S Chairman Taibanganba. He got 45 days basic military training at Laingoubi. He also disclosed that he was holding the rank of S/S Lance Corporal in Dec., 2023 and was promoted and presently holding the rank of S/S Sergeant since March, 2024 for the said banned organization.

Following the disclosures he was arrested from the spot at 0645 hrs by observing formalities. From his Possession recovered (1) 2(two) mobile phones ie.(a) one mobile Redmi A3X 'black' in colour bearing IMEI 1-866024074342182 & IMEI 2-8866024074342190 (b) 1(one) key pad handset Oneme bearing IMEI 1- 359173628495949 & IMEI 2-359173628495956 with Airtel SIM card No. 6909129427 (2) One Aadhar card No. 9468-2564-2320. The same was seized from the spot by observing formalities at 0705 hrs. and videography of the same was done at spot.
