12. First Information contents: Today i.e. 13/11/2025 at 8:45 am the complt. namely SI. Md. Noor Mohammad Shah of WKG-PS reported to OC WKG-PS stating that as per GD entry No. 09/WKG-PS/2025 dated 30/10/2025 regarding report submitted by Deepak Sahu C/o Rajendra Sahu, 66 Mantripukhri, Near UCO Bank, Mantripukhri(East), Koirengei, Imphal East-795002 that they had been awarded a work order by the Manipur State Power Distribution Ltd. For supply and erection of all equipment's for implementation of "System Strengthening Scheme" under SI(Distribution) category in valley districts on Turkey basis vide Office memo No. 2/246(Syst-Strength/S1(D)/TK/2021-MSPDCL Tech/6218-32 dated 7<sup>th</sup> January 2022. As statutory norms, the project is covered under Erection All Risk (EAR) Insurance Policy No. 5006/290456268/00/000 Insurer ICICI Lombard GIC Ltd.

Accordingly, they had started the project and had started transportation and storage of materials at various sites. The same has been handled by sub-contractor Md. Rakib Shah of Kshetri Bengoon Awang Leikai, Imphal East. Unfortunately, owing to the prevailing law and order situation, the implementation of the work was delayed and stored materials were left at the project site i.e. Lamjao Makha Leikai near Community Hall, Indo Burma Sugnu road, Kakching.

Later on, as the law and order situation improved, they had resumed their work, but to their utter surprise, they have noticed that some unknown miscreants taking advantage of the situation had stolen some of the articles from their site i.e. Lamjao Makha Leikai near Community Hall, Indo Burma Sugnu road, Kakching. Hence the report.

In this regard, OC/WKG-PS have taken up the complaint report and made a GD entry vide GD No. 09/WKG-PS/2025 dtd. 30/10/2025 for enquiry of the said matter. The same has been endorsed to me for further enquiry.

As endorsed by OC/WKG-PS, self-have examined the complainant and recorded his statement u/s 180 BNSS. I have physically visited and inspected the spot. Took some photographs of the PO where the complainant have mentioned in the report and also drawn a rough sketch map of the PO. I have met some nearby localities including the Pradhan of Mayeng Lamjao Gram Panchayat. On examination, they disclosed that in the month of Feb. 2024, they have noticed that some electric poles were found lying at Lamjao Makha Leikai near Community Hall. However, they could not ascertain that the electrical equipment were the properties of Industrial Systems LLP or not.

On further examination of the complt., he stated that he had handed over the electrical items (description of the items enclosed herewith as Annexure-A) to one sub-contractor Md. Rakib Shah of Kshetri Bengoon Awang Leikai, Imphal East on 09/02/2024. During the course of enquiry, attempts were made to communicate with the said sub-contractor Md. Rakib Shah of Kshetri Bengoon Awang Leikai, Imphal East. Lastly, he was communicated though phone call (as he was out of the state). On examination, he stated that electrical items like electric poles, AB cable (prepaid wire) and some other nuts and bolts for fitting the electric poles were collected by his 12-13 labourers from the store of Industrial Systems LLP, Lamphel near Opposite Family Court in two DI Tata vehicles and transported to the dumping site located at Lamjao Makha Leikai. However, he was not present while the said items were being transported to Lamjao Makha Leikai.

From the enquiry till date, it is ascertained that the said items enclosed as "Annexure-A" had been unloaded at their project site i.e. Lamjao Makha Leikai near Community Hall. However, where about of the said items could not be trace out. So, it is requested to kindly register a regular FIR case to find out the culprits who had stolen the items and for further investigation, so as to bring to its logical end. Hence the case.
