I am to report that today i.e. 14/11/2025 at around 09:00 pm, a mobile check post comprising the teams of CDO-Unit, Kakching and Kakching PS was established at Pallel Makha Leikai along Satu Road for taking precautionary measure. While conducting frisking and checking, notice one unknown individual who was coming from Khuninglung Village driving one two wheeler vehicle Honda Pleasure B/Regn No. nil. The individual was detained at the checking point for conducting checking. On questioning, the rider of the vehicle has identified himself as Kokhol Khulan aged about 22 yrs. S/o Sanatomba Khulan of Tarao Laimanai, Bukthrol, Chandel. On checking the tool box of the vehicle, notice one nylon bag (mix colour blue+black). On opening the said nylon bag, found 9 (nine) nos. of soap cases suspected to be containing Heroin No. 4 i.e. 3(three) nos. maroon in colour, 2(two) nos. pink in colour, 2(two) nos. blue in colour, 1 no. cream colour and 1 no. olive green in colour. There is some suspicious and need for further search of the said individual and option was given. The individual opted for the search to be conducted in presence of the civil witness. On checking of his jacket found one Redmi 13C mobile phone (light blue in colour) bearing IMEI 1. 869173069698173 and IMEI 2, 869173069698145 along with 2(two) sim cards (1) Airtel sim card no. 8414856669 and (2) Jio sim card no. 6009325930 on the right side pocket. Videography of the same was done at the spot. Accordingly, the recovered items, along with the two wheeler vehicle Honda Pleasure (white in colour) B/Regn. No. nil were seized from the possession of Kokhol Khulan aged about 22 yrs. S/o Sanatomba Khulan of Tarao Laimanai, Bukthrol, Chandel at 10:01 pm. and videography of the same was done at the spot. So, the mentioned above individual was arrested on 10:10 pm from the spot for possession of drugs suspected to be Heroin No. 4 powder. But, weighing of the recovered suspected drugs was not done at the spot due to darkness and apprehension of public mob as well as weather conditions.

Thereafter, all the seized items, along with the arrested individual, were taken to Kakching Police Station for weighing of the recovered suspected drugs. Then, the 9(nine) soap cases containing suspected Heroin No. 4 powder were weighed one by one and found to be 107 gms.(approx.) in total (excluding the weight of the soap cases). The weighing of drugs is also videographed. The seized soap cases containing suspected Heroin No. 4 powder were then properly packed at Kakching Police Station with videography in presence of civil witness.
