On receiving the information, a joint team of CDO/ Unit TBL led by Shri K. Nitaranjan Singh OC/CDO Unit TBL and a team of Thoubal Police Station under the supervision of Shri. Hijam Devendra Singh, MPS, Addl. SP(Ops) Thoubal and under the overall SP/Thoubal District rushed to the said area at around 04:50 a.m. and found two individuals were found detained by general public of the area. On preliminary verification of the two individuals at the spot, they identified themselves as Makakmayum Anisur (23) yrs. S/o. Mk. Majibur of Lilong Lou Tara and Bogimayum Mirja (25) yrs. S/o. BM. Abdul Hakim of Lilong Awang Leikai a gang members of vehicle lifter. Further they disclosed that they had allegedly lifted a TVS Ntorq 125 and kept concealed some distance away from the spot. Accordingly, the said vehicle i.e. a TVS Ntorq 125 bearing registration No. MN01AQ 0628 black in colour was found from the instance of the accused persons. However, at the meantime the local people started forming an unruly mob to attack the two individuals. For the safety of the accused persons and to prevent from any untoward incident they along with the vehicle were brought at DHQ Thoubal. After thorough inspection of the vehicle, it is observed that the lock of the vehicle	-	-	-

				had been broken. Accordingly, the vehicle TVS Ntorq 125 bearing registration No. MN01AQ 0628 black in colour , one 1+ mobile phone with BSNL SIM card bearing mobile No. 9366535613 and one mobile phone Redmi note 8 pro with Airtel SIM card bearing mobile No. 6909004071 were seized from the possession of the two accused persons namely Makakmayum Anisur and Bogimayum Mirja on the same day at 05:25 a.m at DHQ Thoubal. 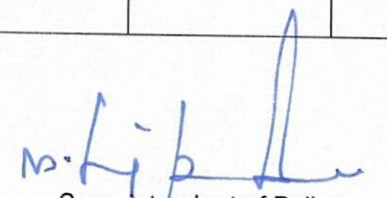

Rajib Khan, In-Charge Cyber Lab, Imphal East District corroborated with own intelligence about the presence of some active members of the outfit KCP who were involved in kidnapping and wrongful detention of persons at Thoubal Wangkhem area under Yairipok Police Station, Thoubal District. Based on the said information and with the permission/authorization of the authority, a combined team of CDO/IE Unit and Andro PS along with women police personnel conducted a C.I.Ops. at the said area under the command of Shri. Khumanthem Dhiraj Karan, MPS, Dy. SP(Ops)IE also looking after the charge of OC-CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops)IE at 4:40 a.m. after providing prior information to Thoubal District Police. In that, one unknown suspicious person was detained for spot verification at a house at Thoubal Wangkhem, Thoubal District.
