

Sir,

I have the honour to state that today i.e. 28/11/2025 at about 01:10 pm, a reliable information was received from our own source and further corroborated from the information input provided by 33 AR regarding the presence of some active cadres of RPF/PLA organization, an outlawed banned organization, in and around Kangla Sangomsang and Kangla Siphai area of Imphal East District with a view to commit prejudicial activities. Based on the information and with the permission of the authority, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW and myself under the command of Shri P. Achouba Meetei, MPS, Dy. SP (CDO), IW and under the supervision of Shri. N. Suraj Singh, MPS, Addl. SP(Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area after giving prior information to Imphal East Police Control Room and conducted search operation at the said area. During that one suspected person was detained at Kangla Siphai near the bridge. During spot verification, the

detainee identified himself as Ngangbam Robinson Singh (28 yrs.) @ Booter S/o. Ng. Ibomcha Singh of Kangla Sangomsang Mayai Leikai, Imphal East District, Manipur.

During preliminary verification, he disclosed that he is an active member of RPF/PLA organization and started working for the said organization since September/October 2023 and he is presently working under the command of one s s Commander Pravin (Ph. No. 8730982449) of RPF /PLA organisation.

Hence, he was arrested from the spot i.e., Kangla Siphai near the bridge at 03:00 pm by observing formalities.

Further, from his possession, (i) one OnePlus Nord CE 2 Lite 5G mobile handset along with two Airtel SIM cards bearing mobile nos. 7085184903 and 9233174684 (as disclosed by him) and (ii) one e-SHRAM card bearing Universal Account Number 7831 6192 2179 were seized at the spot at 03:05 pm by observing due formalities.

Hence, the arrested person and the seized articles are handed over to you for taking further necessary legal action against him.
