Subject: Report.

Sir,

I have the honour to report that today i.e., the 5<sup>th</sup> December, 2025 at about 12:10 p.m. received a reliable information from our own source corroborated with the intelligence of 31 AR about the presence of some active members of the outfit UNLF (Koireng), an alliance of G5, at Pourabi area of Imphal East District. Based on the said information and with the permission/authorization of the authority, teams of CDO/IE Unit conducted a C.I. Ops. at the said area under the command of Inspt. Anilchandra Mutum, Officer-in-Charge CDO/IE Unit, supervised by Shri. Y. Joyraj Singh, Addl. SP(Ops) IE and under the overall supervision of Shri. Shivanand Surve, IPS, Superintendent of Police Imphal East District at 1:10 p.m.

In that, two unknown suspicious person were detained for spot verification and checking at Pourabi near Petrol Pump Lamlai PS, Imphal East. On checking the first detainee, two nos. of mobile phones were found and recovered. On verification, the detainee identified himself as one **Thounaojam Ratan Meitei @ Naocha (44 years) S/o Th. Shamu Meitei of Chingarel Tejpur, Lamlai PS, Imphal East**. On checking the second detainee, one mobile phone and one wallet containing a sum of Rs. 1800/- and one Voter card were found and recovered. On verification, the second detainee identified himself as one **Thounaojam Nison Meitei @ Taton Meitei (25 years) S/o Th. Dhananjoy Singh of Moirangpurel Awang Leikai, Thoubal Dam PS, Imphal East A/p - Chingarel Tejpur, Lamlai PS, Imphal East**.

On further verification, both the detainees stated that they are active members of the outfit UNLF (Koireng), an alliance of G5 joined through one Mr. Dhamendra of UNLF (Koireng), an alliance of G5, in the month of March, 2024 and presently working under the command of one Mr. Ratan of UNLF (Koireng), an alliance of G5. The detainees further stated that they had extorted money from the vehicles plying at NH-2 at Sekmai area of Imphal West District for raising their party fund.

So, the detainee **Thounaojam Ratan Meitei @ Naocha (44 years) S/o Th. Shamu Meitei of Chingarel Tejpur, Lamlai PS, Imphal East** was arrested from the spot i.e. Pourabi near Petrol Pump Lamlai PS, Imphal East at 1:27 p.m. by observing due formalities. The second detainee, **Thounaojam Nison Meitei @ Taton Meitei (25 years) S/o Th. Dhananjoy Singh of Moirangpurel Awang Leikai, Thoubal Dam PS, Imphal East A/p - Chingarel Tejpur, Lamlai PS, Imphal East** was arrested from the spot i.e. Pourabi near Petrol Pump Lamlai PS, Imphal East at 1:30 p.m. by observing due formalities. From the possession of the arrestee, Thounaojam Ratan Meitei; (i) *One mobile phone (Redmi 10) bearing IMEI no. 864726060771875/00 & 864726060771883/00 along with one Airtel SIM card having phone no. 9233521578 and (ii) One mobile phone (OPPO A3X) bearing IMEI no. 879238073499218 & 869238073499200 along with one Airtel SIM card having phone no. 6909148878* were seized at the spot i.e. Pourabi near Petrol Pump Lamlai PS, Imphal East at 1:35 p.m. by observing due formalities. *One mobile phone (Samsung Galaxy S 23) bearing IMEI no. 352772522650165/01 & 352814742650169/01 along with two Airtel SIM cards having phone no. 6909261567 & 8732849808 and one wallet containing a sum of Rs. 1800/- and one Voter card* were seized from the possession of the arrestee, Thounaojam Nison Meitei at the spot i.e. Pourabi near Petrol Pump Lamlai PS, Imphal East at 1:40 p.m. by observing due formalities.

Therefore, the arrested persons along with the seized items are being handed over to you for taking up further necessary legal actions against them.




