Subject:- Report.

Sir,

I have the honour to state that today i.e. 17/11/2025 at about 6:00 p.m. based on a reliable information provided by ANTF/ Imphal-East and further corroborated by FGT Imphal BSF that one car Mahindra TUV 300 Dark Green in colour bearing Regd. No. MN01AX7437 which was travelling from Churchandpur district towards Imphal East was suspected to be carrying certain contraband items in the area of Nongmeibung near Kusum Oil Pump. On receiving the information, I have informed Add. SP/Traffic Shri Ak Sadananda Singh (MPS) ( In-Charge, Anti Narcotic Task Force/IE) about the illegal trafficking of drugs. Accordingly, on the same day at about 6:30 p.m. under the supervision of Shri Ak Sadananda Singh (MPS) ( In-Charge, Anti Narcotic Task Force) Imphal East led by ASI M. Rinash Meitei of ANTF/IE along with a team of 164 Bn BSF, IE rushed to the Nongmeibung area near Kusum Oil Pump and conducted random frisking and checking. In that, the said Mahindra TUV 300 which was coming from Konung Mamang towards Kshetrigao via Nongmeibung road is detained on the spot for checking and verification. As per lawful procedure, we identified our identities as police personnel of ANTF, Imphal East. Further, I told them that their body and belongings needed to be searched. On being asked whether they would like to search before a Gazetted Officer or before a Magistrate. None of the civilians available at the spot were willing to be witnesses, so I asked my police party, in particular, who accompanied me to be the witnesses. Thereafter, in presence of the Executive Magistrate and witnesses conducted search of the vehicle, on checking inside the vehicle 7(seven) soap cases suspected to be containing contraband items was found from inside the gear lever cover. Further, I have informed Add. SP/Traffic Shri Ak Sadananda Singh (MPS) ( In-Charge, Anti Narcotic Task Force/IE) and one Executive Magistrate of Imphal East namely Shri Sapam Nirva Devi, Imphal East to conduct search of the vehicle. On arrival of Executive Magistrate, led by a team of ANTF/Imphal-East conducted search of the vehicle and the said 7(seven) soap cases suspected to be containing No. 4 Heroin Powder was taken out from the gear lever cover. After opening the soap case found a packet in a transparent plastic pouch suspected to be No. 4 Heroin powder. Further, using the testing kit, the said powder from soap case was tested and found positive as Heroin powder which is a banned drug. On weighing the said 7(seven) packets of Heroin powder, using weighing scale. On weighing No. 1) Soap case green in colour mark as "A" it is found containing 11.43 grams without container, 2) Soap case green in colour mark as "B" it is found containing 11.15 grams without container, 3) Soap case green in colour mark as "C" it is found containing 10.80 grams without container, 4) Soap case green in colour mark as "D" it is found containing 11.00 grams without container, 5) Soap case green in colour mark as "E" it is found containing 10.85 grams without container, 6) Soap case grey in colour mark as "F" it is found containing 11.00 grams without container and 7) Soap case red in colour mark as "G" it is found containing 11.40 grams without container. Further, on preliminary verification at the spot, the detainees identified themselves as namely 1) Md. Ajimuddin s/o Md. Islauddin of Kwakta Pangal Lamkhai Ward No. 6, Bishnupur District and 2) Md. Iqbal s/o Md. Abdul Kalam of Kwakta Bazar, Ward No. 6, Bishnupur District. They admitted that they are a drug peddler and they used to sell to the interested customers. Thereafter, by observing the formalities the detainees were arrested from the spot at 6.35 pm and the following items were seized on the spot at 6.40 pm:

- 1) 7(seven) soap cases containing No. 4 Heroin from inside the vehicle.
- 2) One Samsung S23 Ultra Mobile handset Model SM-S918B/DS, Serial No. RZCW0FOEDE, IMEI No.1: 353835883924773, IMEI No. 2: 353901653924771 seized from the possession of Md. Ajimuddin.
- 3) One Pan Card of Md. Ajimuddin bearing number EPPPA4107E.
- 4) One driving license of Md. Ajimuddin bearing number MN0220230001327.
- 5) One Aadhar Card of Md. Ajimuddin bearing number 290583288802.
- 6) Smart RC card bearing number MN01AX 7437 from the possession of Md. Ajimuddin.
- 7) One Redmi 15(5G) mobile handset Model No. 25057RN09I, IMEI No. 1: 868300076041065, IMEI No. 2: 868300076041073 from the possession of Md. Iqbal.
- 8) One Aadhar card of Md. Iqbal bearing No. 971897187606.
- 9) One Voter ID card of Md. Iqbal.
- 10) One Mahindra Vehicle TUV 300 bearing Regd. No. MN01AX-7437, Chassis No. MA1NA2VZXH6G481 and Engine No. VZH651190 dark green in colour.

During preliminary interrogation on the spot, they disclosed that the said No. 4 Heroin is to be delivered at the residence of Eki Sakip of Kshetrigao Yumkhaibam Leirak, Imphal-East. Immediately, the said combined team rushed to the residence of Eki Sakip and conducted house search. During the house search 3(three) soap cases suspected to be containing No.4 Heroin and two numbers of Baba Black tobacco containers were found in the 1<sup>st</sup> floor godown containing total numbers of 180 vials No. 4 Heroin. However, Eki Sakip escaped from the spot and he is still evading from arrest. On weighing the said 3(three) packets of Heroin powder, using weighing scale, No. 1) Soap case blue in colour mark as "H" it is found containing 12.00 grams without container, 2) Soap case green in colour mark as "I" it is found containing 12.00 grams without container and No. 3) Soap case green in colour mark as "J" it is found containing 12.00 grams without container. Thereafter, the said 3(three) soap cases containing No. 4 Heroin and the two numbers of Baba Black tobacco containers containing total numbers of 180 vials No. 4 Heroin were seized on the spot at 7.15 pm by observing necessary formalities in presence of the witnesses.

It is therefore, the arrested accused persons namely No.1) Md. Ajimuddin (25) yrs s/o Md. Islauddin of Kwakta Pangal Lamkhai Ward No. 6, Bishnupur District and 2) Md. Iqbal (22) yrs s/o Md. Abdul Kalam of Kwakta Bazar, Ward No. 6, Bishnupur District along with the seized articles are being handed over to you for taking up necessary legal action against them.

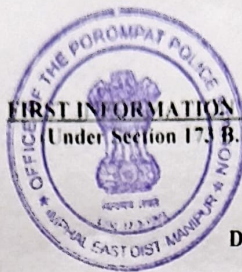
