12. First Information Contents:

Today, received an information at about 01:30 pm that on the same day i.e. 20/11/2025 at about 1:20 pm suddenly an unruly mob led by the volunteers of COCOMI including IDP'S, Meira Paibies (Women Folks), Club Member and other who came out and started approaching towards Hapta Kangjeibung for protesting against the upcoming Sangai Festival, 2025 at Hapta Kangjeibung which is to be organize by state Government of Manipur. That, the Police personnel who were on duty tried to control the unruly mob. Despite of calming down, the unruly mob continued to escalate more violence by swarming towards the police personnel who were on at the spot. That, the Police personnel warned them to stop their action. But despite of the Police warning, the mob became more violent towards the Police personnel and obstructed the police personnel including the Officers who were discharging their legal duty. Therefore, after taking permission from the concerned Executive Magistrate, the police team had to resort to fire some rounds of tear smoke/ tear gas shells as well as mild lathi charge towards the rioters to disperse the mob by observing necessary formalities with due law.

Hence a suo-mottu case under FIR No. 297(11)2025 PRT-PS u/s 191(2)(3)190 BNS-2023 has been registered for investigation.


