Sir,

I have the honour to state that today i.e. 25/11/2025 at about 11:40 am, a reliable information was received from our own source and further corroborated from the information input provided by 33 AR regarding the presence of some active cadres of PREPAK organization, an outlawed banned organization, in and around Top Awang Leikai area of Imphal East District with a view to commit prejudicial activities. Based on the information and with the permission of the authority, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW and myself under the command of Shri P. Achouba Meetei, MPS, Dy. SP (CDO), IW and under the supervision of Shri. N. Suraj Singh, MPS, Addl. SP(Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area after giving prior information to Imphal East District Police Control Room and conducted search operation at Top Awang Leikai area. During that one suspected person was detained at a house located at Top Awang Leikai, Top Dusara, Imphal East District, Manipur. During spot verification, the detainee identified himself as Laishram Amar Singh (38 yrs.) @ Amarjit s/o L. Kanta Singh of Top Awang Leikai, Top Dusara, Imphal East District, Manipur (who later identified himself as the resident of the said house). During preliminary verification, he disclosed that he is an active member of PREPAK (Pro) organization (a faction of PREPAK organization) and started working for the said organization in the month of November, 2025 and presently working under the command of one s/s Commander Premjit of PREPAK (Pro) organization from Moirang area. He further disclosed that under the instruction of his commander, he was staying at Ukhongshang area to commit prejudicial activities. Hence, he was arrested from the spot i.e., from his residence at 12:53 pm by observing formalities. Further, from his possession, (i) one Redmi 14C 5G mobile handset without any SIM card and (ii) one Aadhaar card bearing no. 3785 4976 1433 were seized at the spot at 12:58 pm by observing due formalities. Hence, the arrested person and the seized articles are handed over to you for taking further necessary legal action against him.
