Sir,

I have the honour to report that today i.e., 26th November, 2025 at about 3:00 p.m. received a reliable information from our own source corroborated with the intelligence of 33 AR about the presence of some active members of the outfit KYKL (SOREPA) group in and around Porompat, Imphal East District. Based on the said information and with the permission/ authorization of the authority, teams of CDO/IE Unit conducted a C.I. Ops. at the said area under the command of Inspt. Anilchandra Mutum, Officer-in-Charge CDO/IE Unit, supervised by Shri. Y. Joyraj Singh, Addl. SP(Ops) IE and under the overall supervision of Shri. Shivanand Surve, IPS, Superintendent of Police Imphal East District at 4:10 p.m.

In that, one unknown suspicious person was detained for spot verification at Porompat in front of Elle's Cake and Bake Shop, Imphal East District. On spot verification, the detainee identified himself as one, Thangjam Abinash Singh @ Amuba @ Picktru (19 years) S/o Th. Ibungo Singh of Heirolk Part-III, Kabo Leikai, Heirolk PS, Thoubal District, A/p - Nongmeibung Wangkheirakpam Leikai, Porompat PS, Imphal East District.

On further verification, the detainee stated that he is an active member of the outfit KYKL (SOREPA) group joined through one Mr. Khaba of KYKL (SOREPA) in the month of November, 2024 and got his basic military training for twenty days under the command one Mr. Gokul of KYKL (SOREPA) with allotted army no. 31 of 6th batch of the year 2024. The detainee further stated that he is presently working under the command of one Mr. Keipha of KYKL (SOREPA) group. He further stated that, he is involved in recruiting new cadres to their outfit on the advice of the said Mr. Gokul of KYKL (SOREPA).

So, the detainee was arrested from the spot i.e. Porompat in front of Elle's Cake and Bake Shop at 4:27 p.m. and seized; one mobile phone (Infinix Note 9) bearing IMEI no. 352408118564843 & 352408118556850 along with two nos. of SIM card having phone no. Airtel-8119981688 & Jio -6009124807 from his possession at the spot i.e. Porompat in front of Elle's Cake and Bake Shop at 4:35 p.m. by observing due formalities.

Therefore, the arrested person along with the seized mobile phone is being handed over to you for taking up further necessary legal actions against him.
