

Sir,

I have the honour to report that yesterday i.e., 26<sup>th</sup> November, 2025 at about 2:00 p.m. received a reliable information from our own source and 165 TA corroborated with the intelligence of 7 Madras Regiment about the presence of some active member of the outfit KCP at Hatta Golapati area of Imphal East District. Based on the said information and with the permission/ authorization of the authority, teams of CDO/IE Unit Conducted a C.I. Ops. at the said area under the command of Inspt. Anilchandra Mutum, Officer-in-Charge CDO/IE Unit, supervised by Shri. Y. Joyraj Singh, Addl. SP(Ops) IE and under the overall supervision of Shri. Shivanand Surve, IPS, Superintendent of Police Imphal East District at 2:40 p.m. In that, one suspected person was detained for spot verification and checking at a house at Hatta near Public Hospital, Imphal East District. On checking the detainee, one sling bag containing one Extortion Receipt of the outfit KCP (PWG) group, one brown paper envelop and one Ink Remover were found and recovered from his possession. On verification, the detainee identified himself as Md. Ayub Khan @ Thoiba (28 years) S/o Md. Abdul Zalil of Hiyangthang Tarahei Konjil, Wangoi PS, Imphal West District A/p – Hatta near Public Hospital, Imphal East District. On further verification, the detainee stated that he is an active member of the outfit KCP (PWG) group, joined through one Mr. Taibang of KCP (PWG) in the month of November, 2023 and presently working under the command of one Mr. John of KCP (PWG) group. Further, the detainee stated that he took the above recovered Extortion Receipt from one of his associates namely, Md. Salim of KCP (PWG) about three months before.

So, the detainee was arrested from his residence i.e. Hatta near Public Hospital, Imphal East at 3:18 p.m. and seized; (i) one Extortion Receipt of KCP (PWG) duly signed by one Th. Thanil, Dept of Finance, (ii) one brown paper envelope, (iii) one ink remover and (iv) one sling bag from his possession at his residence i.e. Hatta near Public Hospital, Imphal-East at 3:20 p.m. by observing due formalities

On further verification it came to learnt that the said Md. Salim is presently waiting for him at Kairang Mamang Leikai, Imphal East. Immediately, our team along with the arrestee rushed to the said place and arrested one Md. Salim (35 years) S/o (Late) Md. Salam of Kairang Mamang Leikai, Heingang PS, Imphal East District from Kairang Mamang Leikai, Imphal East at 7:55 p.m. and seized one mobile phone (Redmi 6A) bearing IMEI no. 868739046576611 & 868739046576629 along with one Jio-SIM card having phone no. 6009213035 from his possession at 8:00 p.m. by observing due formalities. On verification, the arrestee (Md. Salim) stated that he is an active member of the outfit KCP (PWG) group joined through one Mr. Jagat of KCP (PWG) in the month of November, 2024 and presently working under the command of one Mr. Haoba of KCP (PWG) group.

On further examination of both the arrestees, they revealed that one of their associates namely, Md. Ali is presently residing at his residence at Hatta near Public Hospital, Imphal East. Immediately our team along with the arrestees rushed to the said house and on the pointing of the arrestees, one Md. Ali (46 years) S/o Md. Najimuddin of Hatta near Public Hospital, Imphal East District was arrested from his residence i.e. Hatta near Public Hospital, Imphal East District at 8:46 p.m. and seized one mobile phone (VIVO) bearing IMEI no. 867116045725435 & 867116045725427 along with one Airtel SIM card having phone no. 8258932413 from possession at 8:50 p.m. by observing due formalities.

On further verification of the three arrestees, they stated that they had extorted a huge amount of money from the general public, oil pumps, private schools and govt. colleges located at Imphal East District under the command of the said Mr. Jagat and one Mr. Malei of KCP(PWG) group for raising their party fund.
