

Sir,

I have the honour to report that today i.e., 29<sup>th</sup> November, 2025 at about 10:30 a.m. received a reliable information from our own source corroborated with the intelligence of 33 AR about the presence of some active members of the outfit KCP in and around Wangkhei Ayangpalli Road, Imphal East District. Based on the said information and with the permission/ authorization of the authority, teams of CDO/IE Unit conducted a C.I. Ops. at the said area under the command of Inspt. Anilchandra Mutum, Officer-in-Charge CDO/IE Unit, supervised by Shri. Y. Joyraj Singh, Addl. SP(Ops) IE and under the overall supervision Shri. Kh. Shivakanta Singh, IPS SP/IW also looking after the charge of Superintendent of Imphal-East District at 11:30 a.m.

In that, one unknown suspicious person was detained for spot verification at Wangkhei Ayangpalli Road, near Coffee Culture shop, Imphal East District. On spot verification, the detainee identified himself as one, **Kiyam Hemanta Singh @ Nanao (36) S/o K. Ingocha Singh of Ithai Wapokpi Mayai Leikai, Kumbi Police Station, Bishnupur District.**

On further verification, the detainee stated that he is an active member of the outfit KCP (Taibangnganba) group joined through one Mr. Pari of KCP (Taibangnganba) group in the month of January, 2024 and stayed at their military camp at Laingoubi, Bishnupur District along with the said Mr. Pari presently and presently working under the command of one Mr. Taibangnganba of KCP (Taibangnganba) group. It has been further revealed that he participated in an interview while wearing combat attire and armed with assault rifles, in which Taibanganba, the Commander-in-Chief of the banned outfit KCP (Taibanganba) was giving the interview. The interview, recorded by a YouTuber, was subsequently circulated widely, and the video has since gone viral on Facebook

So, the detainee was arrested from the spot i.e. Wangkhei Ayangpalli road, near Coffee Culture shop at 12:01 p.m. and seized **one mobile phone (Redmi 9A) bearing IMEI no. 860868041568139 & 860868041568147 along with one Jio SIM card having phone no. 9863492096** from the spot i.e. Wangkhei Ayangpalli Road, near Coffee Culture shop at 12:05 p.m. by observing due formalities.

Therefore, the arrested person along with the seized mobile phone is being handed over to you for taking up further necessary legal actions against him.
