I have the honour to report that today i.e., the 17th November, 2025 at about 4:00 a.m. received a reliable information from our own source corroborated with the intelligence of No. 2 DET AR FIU (No. 2 Detachment Assam Rifles Filed Intelligence Unit) and 31 AR about the presence of some anti-social elements at Tiger Camp Village, Imphal East District. Based on the said information and with the permission/authorization of the authority, a combined team of CDO/IE Unit & 31 AR conducted a C.I. Ops. at the said area under the command of Inspt. Anilchandra Mutum, Officer-in-Charge CDO/IE Unit, supervised by Shri. Y. Joyraj Singh, Addl. SP(Ops) IE and under the overall supervision of Shri. Shivanand Surve, IPS, Superintendent of Police Imphal East District at 5:00 a.m. In that, one unknown suspicious person was detained at a house at Tiger Camp village, Imphal East District. On spot verification, the detainee identified himself as one, **Thangjam Thougamba Meitei @ Chingshang (26 years) S/o Th. Sunil Meitei of Tiger Camp village, near Community Hall, Imphal East District.** On verification, the detainee stated that in the month of August, 2023 one of his associates namely, Mr. Tomba had handed over him one .32 pistol along with one magazine. The detainee further stated that the said pistol was kept conceal at the foothill of Tiger Camp village Lai Ching village, near Pukhri Achouba, Imphal East. Immediately, our combined team along with the detainee rushed to the said place and conducted a thorough search operation of the said area. While our combined team conducting the search operation, a large mob approached towards our CDO team

and enquired why the person was being detained and conducted the searched operation of the area. Considering the situation and controlling the mob, the procedure of taking the videography could not be carried out by our police personnel.

During that, one .32 Pistol along with one magazine was found and recovered underneath a thick bush at Tiger Camp village, Lai Ching near Pukhri Achouba, Imphal East. So, the detainee was arrested from the spot i.e. Tiger Camp Village, Lai Ching near Pukhri Achouba, Imphal East at 6:25 a.m. and seized one .32 Pistol along with one magazine at the spot i.e. Tiger Camp Village, Lai Ching near Pukhri Achouba, Imphal East at 6:30 a.m.

Therefore, the arrested person along with the seized pistol is being handed over to you for taking up further necessary legal actions against him.


