Complainant namely Md. Firoz Shah Asst. Sub Inspector of BPR (Now attached with CDO-IW) lodge a written report to OC/APS stating that, today i.e. 07/11/2025 at about 06:25 am, a reliable information was received from their own source and further corroborated from the information input provided by 33 AR regarding the presence of some active cadres of PREPAK organization, an outlawed banned organization, in and around Andro area of Imphal East District with a view to commit prejudicial activities. Based on the information and with the permission of the authority, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW assisted by W/Inspector Shamjetsabam Sarjubala Devi of CDO-IW and himself under the command of Shri P. Achouba Meetei, MPS, Dy. SP (CDO), IW and under the supervision of Shri. N. Suraj Singh, MPS, Addl. SP(Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area after giving prior information to Imphal East District Control Room and conducted search operation at Andro Kharam Leikai area. During that one suspected woman was detained at a house located at Andro Kharam Leikai. On spot verification, the detainee identified herself as Phanjoubam Thanjamanbi Devi (22 yrs.) @ Chaibi @ Malemnganbi D/o. Ph. Shyamkeshor Singh of Andro Kharam Leikai, Imphal East District Manipur (who later identified herself as the resident of the said house). During preliminary verification, she disclosed that she is an active cadre of PREPAK organization and joined the said organization in October/November 2023 through one Chingshang of PREPAK organization from Jiribam area and she got Basic Military Training for 45 days at Sawombung Wairi area and was allotted Army no. (but unable to remember). She also disclosed that she worked under the command of the above mentioned Chingshang as her s/s Commander. Hence, she was arrested from the spot i.e., from her residence at 08:18 am by observing formalities. And from her possession, (i) one Redmi 9i mobile handset along with two Airtel SIM cards



bearing mobile numbers (a) 9378023008 and (b) 7085683464 (as disclosed by her), (ii) one Redmi Note 10 Pro Max mobile handset along with one Airtel SIM card bearing mobile number 8731908184 (as disclosed by her), (iii) one Nokia keypad mobile handset without SIM card and (iv) one Aadhaar card bearing no. 7504 2287 8743 were seized at the spot at 08:24 am by observing due formalities. Hence, the arrested person and the seized articles are handed over to you for taking further necessary legal actions against her. Hence, the case.
