With due respect, I the undersigned would like to request the above mentioned subject that, I am internally displaced person and effected from Kamu Tangnom Village, Island Sub- Division, Kangpokpi District, Manipur, presently taking shelter at Kangpokpi Ward No. 2 due to the prevailing law and order situation, wish to submit the following for your kind consideration and necessary action.

That, during the unfortunate communal violence which broke out on 3rd May 2023, my entire villages, houses, and properties were looted and burnt down to ashes compelling us to take at a relief camp and in rented accommodation at Kangpokpi Ward No.2.

Since then, due to continued security concerns. I have not been able to return to my native village. However, I have recently come to know that my paddy fields, located near Kamu Tangnom Village an area of 5(five) hectares under Kamu Yaithibi Loukon has been illegally occupied and cultivated by some unknown persons, suspected to be (1) Malemnganba S/o Khongjai Singh of Andro Awang Leikai, and (2) Sarat Amuba of Andro Machengpat and party for the past two and a half years. In order to verify this, I deputed a trusted person to the said location on 16/10/2025, who confirmed the unauthorized cultivation and also obtained geo-tagged photographs of the land under illegal occupation. As the lawful owner of the said land, I deeply aggrieved by this illegal encroachment and unauthorized occupation.

I, therefore, most respectfully request your kind office to conduct the-spot verification and to take immediate steps for restoration of possession and protection of our agricultural land.

It is further requested to register an FIR and take up appropriate legal action against the illegal occupants and cultivators according to law.
