(Red Army) was recovered from his bedroom at his instance.

I have the honour to state that today i.e. 25/03/2025 at about 02:20 pm, a reliable information was received from our own source and further corroborated from the information provided by 33 AR regarding the presence of some active cadres of PREPAK (Pro) (a faction of PREPAK) organisation in and around Top Khongnangkhang area of Imphal East District with a view to commit prejudicial activities like extortion of money from the general public and shops etc. Acting on the information, a team of CDO-IW led by Shri P. Achouba Meitei, M.P.S., DSP(CDO)/IW and Inspector Gunachandra Chanam, OC-CDO-IW and myself under the command of Shri M. Amit Singh, Addl. SP(Ops.)/IW and overall supervision of Shri Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area after giving prior information to Imphal East District Police Control Room (OSCAR 1) at around 02:24 pm and conducted search operation at Top Makha Leikai area of Imphal East District. During search at the a house located at Top Makha Leikai near Shagolsem Pukhri, Imphal East District, two persons who later identified themselves as (i) Wangkheirakpam Romeo Meitei (4 yrs.) @ Baruni S/o. (L) W. Momocha Meitei of Soibam Leikai Khanglabung Leirak, Imphal East District (later found to be owner of the house) a/p Top Makha Leikai near Shagolsem Pukhri, Imphal East District, and (ii) Thokchom Nepolian Singh (22 yrs.) @ Abothe S/o. Th. Dhamen Singh of Khurai Ningthoubung Leirak, Imphal East District were detained for spot verification.

On spot checking, the following articles were recovered from the possession of:

- (1) Wangkheirakpam Romeo Meitei: (i) one Redmi 9 mobile handset along with one Airtel SIM card bearing mobile no. 6906930383 (as disclosed by him), (ii) one Redmi Y1 Lite mobile handset along with one Airtel SIM card bearing mobile no. 9862949273 (as disclosed by him), (iii) one black wallet containing a sum of Rs. 11,800/- (rupees eleven thousand eight hundred only) and one Aadhaar card bearing no. 8138 7856 0414.
- (2) Thokchom Nepolian Singh: (i) one Redmi Note 10 mobile handset along with one Airtel SIM card bearing mobile no. 7085344941 (as disclosed by him).

On spot verification, both Wangkheirakpam Romeo Meitei and Thokchom Nepolian Singh disclosed that they are the active members of PREPAK (Pro) (a faction of PREPAK) organisation.

During preliminary verification:

- (i) Wangkheirakpam Romeo Meitei disclosed that he joined PREPAK organisation in the year 2014 and presently working under the command of s/s Sergeant Major Lalngakpa (Ph. No. 9863326392/6909798191) of PREPAK (Pro) organisation from Heirok.
- (ii) Thokchom Nepolian Singh disclosed that he started working for PREPAK (Pro) organisation through the above mentioned Wangkheirakpam Romeo Meitei since March, 2024 and presently working for the said organisation under the command of the above mentioned Wangkheirakpam Romeo Meitei as his s/s Commander.

On further verification, they disclosed that on 22/03/2025 (Saturday), they along with their Commander Lalngakpa collected money from a mobile shop located at Paona Bazar and Commander Lalngakpa gave them a sum of Rs. 1,000/- from the extortion money and on the same day, under the
