The post or content was shared widely and gained significant attention, leading to distress the general public. That, the act of the admin of facebook account "Porompat 360" is creating provocation among the people of the state and promoting enmity between different section of the people in the state.

Further, by spreading such fake news with communal sensitive content that have the potential to disturb public peace and tranquility which may further escalate fresh tension in the state.

Hence, a suo-mottu case under FIR No. 74(4)2025 PRT-PS u/s 196(1)/352 BNS-2023 has been registered for investigation.

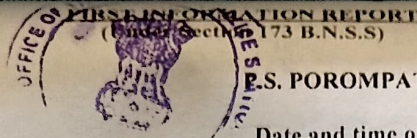
