I have the honour to report that today i.e. the 3<sup>rd</sup> April, 2025 at about 1:00 p.m. received a reliable information from 4 AR corroborated with our own intelligence about the presence of some active members of the outlawed outfit UPPK at Sanjenthong Bridge area of Imphal East District. Based on the said information, teams of CDO/IE Unit under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. (Ops) Imphal-East rushed to the said area and conducted a C.I. Ops. at the said area at about 2:00 a.m.

As a part of the operation, random frisking and checking to the suspected passersby. In that two scooters, were detained for spot checking and verification. On checking the first driver, three nos. of ID cards and one mobile phone were found and recovered. On verification, the detainee identified himself as one Laishram Birjit Singh (39 years) S/o Imochouba Singh of Keishampat Thokchom Leikai, Imphal Police Station, Imphal West District. On checking the second detainee, two nos. of ID cards and one mobile phone were found and recovered. On verification, the detainee identified himself as one Chungkham Milan Singh (31 years) S/o Ch. Joy Singh of Naoremthong Khullem Leikai, Imphal PS, Imphal West District.

On further verification of the first detainee (Birjit) stated that he joined the said outlawed outfit through one Mr. Khagemba @ Ajit of UPPK in the month of October, 2024 and presently working under the command of the said Mr. Khagemba of UPPK. The arrestees were involved in extortion of money from the various private schools located at Imphal under the command of the said Mr. Khagemba of UPPK. On verification of the second arrestee (Milan) stated that he joined the outfit UPPK in the month of the March, 2025 though the first detainee, Laishram Birjit Singh, and presently working under his command.

So, the detainees were arrested from spot i.e. eastern side of Sanjenthong Bridge at about 2:43 p.m. by observing due formalities.

One scooter (Honda Activa), red in colour bearing regd. no. MN-01C/2693 bearing Engine no. JC44E-5669439 and Chassis no. ME4JC448LC7668934TA-1423 along with registration certificate, one mobile phone (Nokia (TA-1423) bearing IMEI no. 357343645989701/5 along with one Airtel SIM card bearing no. 8991160990027227880U, one ADHAR card, one PAN card and one Voter Card were seized from the possession of the arrestee Laishram Birjit Singh at the spot i.e. eastern side of Sanjenthong Bridge at 2:44 p.m. by observing due formalities.

One scooter (Honda Activa), PS blue in colour, without regd. no. bearing Chassis no. ME4JK430ASW015630 and engine no. JK43EW0015258, one mobile phone (DIZO-DH2002 bearing IMEI NO. 862961050240647 & 862961051452647 along with one Airtel SIM Card bearing no. 8991160990014296964U, one PAN card and one Voter Card were seized from the possession of the arrestee Ch. Milan Singh at the spot i.e. eastern side of Sanjenthong Bridge at 2:44 p.m. by observing due formalities.

Therefore, the arrested person is being handed over to you for taking up further necessary legal actions against them.

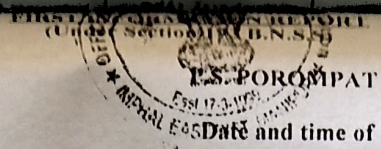
