Sir,

I have the honour to report that today i.e. the 11th April, 2025 at about 1:30 p.m. based on a credible information about the presence of some active members of the outlawed outfit KYKL at Khural Lamlong Bazar and its surrounding area of Imphal East District. Based on the said information, a combined team of CDO/IE Unit and a column of 4 AR under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops) Imphal-East rushed to the said area and conducted a random frisking and checking to the suspected passersby at the eastern side of Lamlong Bridge at 2:10 p.m.

In that, one suspected person was detained for checking and verification. On checking the detainee body, one mobile phone was found and recovered from his possession. On verification, the detainee identified himself as one Molrangthem Suranjoy Meitei @ Thousinba (31 years) S/o M. Surjit Meitei of Sagolmang Awang Leikal, Sagolmang PS, Imphal East District. On further verification, the detainee stated that he is an active cadre of the out outfit KYKL joined through one Mr. Nungshithoi of KYKL in the month of December, 2023. The detainee further stated that he got his basic military training in the same year at Metwit, Myanmar for 45 days under the command of one s/s – Rohan. He further stated that after completion of his basic military training he was deployed at Tamu, Myanmar and presently working under the command of one Mr. Gune of KYKL.

So, the detainee was arrested from the spot i.e. eastern side of Lamlong Bridge, Imphal East District at 2:42 p.m. by observing due formalities and seized one mobile phone (KECHAODA - K332) bearing IMEI no. 868185030498646 & 868185030498653 without SIM cards at the spot i.e. Lamlong Bridge, Imphal East District at 2:45 p.m.

Thereafter, the arrested person along with the seized mobile phone is being handed over to you for taking up further necessary legal actions against him.
