

Sir,

I have the honour to report that today i.e., 1st December, 2025 10:30 a.m. received a reliable information from our own source corroborated with the intelligence of 33 AR about the presence of an active member of the outfit UNLF at Keirao Bitra Awang Leikai, Imphal East District. Based on the said information and with the permission/authorization of the authority, teams of CDO/IE Unit conducted a C.I. Ops. at the said area under the command of Inspt. Anilchandra Mutum, Officer-in-Charge CDO/IE Unit, supervised by Shri. Y. Joyraj Singh, Addl. SP(Ops) IE and under the overall supervision of Shri. Shivanand Surve, IPS, Superintendent of Police Imphal East District at 11:30 a.m.

In that, one unknown suspicious person was detained for spot verification and checking at Keirao Bitra Awang Leikai, Imphal East District. On checking the detainee body, one mobile phone was found and recovered from his possession. On spot verification, the detainee identified himself as one, **Malemnganba Ningombam @ Yaikanba (22 years) S/o (Late) N. Samu Singh of Bashikhong Kongba Irong, Iribung PS, Imphal East District. A/p - Keirao Bitra Awang Leikai, Iribung Police Station, Imphal East District.** On further verification, the detainee stated that he is an member of the outfit UNLF (Koireng) group joined through one Mr. Pari of UNLF (Koireng) group in the month of September, 2024 and presently working under the command of one Mr. Brojen of UNLF (Koireng) group.

So, the detainee was arrested from the spot i.e. Keirao Bitra Awang Leikai, Imphal East District at 12:01 p.m. and seized *one mobile phone (POCO M7) bearing IMEI no. 861697076573725 & 861697076573733 along with two Airtel SIM card having phone no. 8416016341 and 873000760* at the spot i.e. Keirao Bitra Awang Leikai, Imphal East District at 12:10 p.m. by observing due formalities.

Therefore, the arrested person along with the seized mobile phone is being handed over to you for taking up further necessary legal actions against him.
