Sir,

I have the honour to report that today i.e. the 1st October, 2025 at about 3:30 a.m. received an information from a reliable source about the concealment of a huge nos. of arms and ammunitions by unknown arms miscreants in general area of Hanna Ching, Heingang and its surrounding area of Imphal East District. Based on the said information, teams of CDO, Imphal-East Unit and 1 (one) team of HNG/PS led by Inspt. H. Sachindra Singh OC-HNG/PS conducted a searched operation at Hanna Ching, Heingang and its adjoining foothill areas of Imphal-East District under the command of Shri. Khumanthem Dhiraj Karan, MPS, Dy. SP(Ops)IE also looking after the charge of OC-CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops)IE at 4:40 a.m.

In that, the undernoted arms and ammunitions, other items were found and recovered.

Accordingly, the above recovered arms and ammunitions along with the sack bag were seized at the spot i.e. foothill of south-western side of Hanna Ching, Heingang, which is about 300 metres away to the south-eastern side of PHC Heingang, Imphal East at 5:20 a.m. by observing due formalities.

Thereafter, the seized items are being handed over to you for taking up further necessary legal procedures.
