On 04/10/2025 at 2:00 pm SI T. Shyam Singh of CDO/IW lodge a written report to OC/HNG-PS stating that on 04/10/2025 at about 12:05 am, a reliable information was received regarding the presence of some active cadres of KCP (PWG) organization (a faction of KCP organization), an outlawed banned organization, in and around Laipham Khunou area of Imphal East District with a view to commit prejudicial activities like extortion of money from general public. Based on the information and with the permission of the authority, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW and myself under the command of Shri K. Dineshkumar Singh, MPS, Dy. SP (CDO), IW and under the supervision of Shri. Gaurav Dogra, IPS, Addl. SP(Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area after giving prior information to Imphal East District Police Control Room and conducted search operation at Laipham Khunou Maning Leikai area. During that one suspected person was detained at a house located at Laipham Khunou Maning Leikai. During spot verification, the detainee identified himself as Shamulailatpam Prakash Sharma (44 yrs.) @ Bungo S/o. (L) Sh. Krishna Chandra Sharma of Laipham Khunou Maning Leikai, Imphal East District, Manipur (who later identified himself as the resident of the said house). During preliminary verification, he disclosed that he is an active member of KCP (PWG) organization (a faction of KCP organization) and started working for the said organization through two persons namely one Homen @ Homendro (Ph. No. 7005132765) of KCP (PWG) organization from Sagolband area and one Dolen of KCP (PWG) organization from Kangjabi area since September, 2025. He also disclosed that he is presently working under the command of one s/s Chairman Lamyamba Khuman of KCP (PWG) organization. He further disclosed that under the instruction of his commander Lamyamba Khuman (the above mentioned), he was involved in extortion activities by serving monetary demands/threats to hospitals including RIMS Hospital and general public in valley area for raising their party fund. Hence, he was arrested from the spot i.e., from his residence at 12:54 am by observing formalities. Further, from his possession, (i) one vivo Y33s mobile handset along with one Jio SIM card bearing mobile no. 8787603694 (as disclosed by him) and (ii) one Aadhaar card bearing no. 7757 0936 3785 were seized at the spot at 12:59 am by observing due formalities. Hence the case.

Hence, the arrested person and the seized articles are handed over to you for taking further necessary legal action against him.
