FIR Contents :- on 05/10/2025 at 03:00 am, complainant namely M. Rinash Meitei, ASI/ IE district, Member, ANTF/IE lodged a written report to OC/HNG-PS stating that on 05/10/2025 at around 00.10 hrs, on receipt of reliable information given by FGT Imphal BSF regarding the presence of drug traffickers and a huge consignment of contraband items in the presence of drug traffickers and a huge consignment of contraband items at the residence of one Md Ithem (39 yrs) S/o Md. Ujeruddin of Khomidok Sorok Mapal and Raju Khan (41) yrs S/o Shamu Khan of Khomidok Sorok Mapal. The said information was reduced in writing and was placed before Shri Ak. Sadananda Singh, Addl. SP (Traffic) Imphal-East (Nodal Officer ANTF Imphal-East) for executing the information into action. He obtained authorisation to search the premises of Md Ithem (39 yrs) S/o Md. Ujeruddin of Khomidok Sorok Mapal and Raju Khan (41) yrs S/o Shamu Khan of Khomidok Sorok Mapal from Addl. SP (Traffic) Imphal-East. On approval of the source report, a joint team comprising of personnel from CDO Unit Imphal East, Heingang Police Station, ANTF/Imphal-East, and 164 Bn BSF was constituted for execution of the secret information. Accordingly, the search operation was launched under the supervision of Y. Joyraj Singh, Addl (Ops) Imphal-East and the detailed teams proceeded towards the target locations from 0100 hrs. The Joint team was instructed to conduct search at the above noted two houses simultaneously from 0120 hrs. On reaching the residence of Md. Ithem Khan of Khomidok Sorok Mapal, the teams started the search operation and during the search, cash amounting to ₹27,52,500/- (Rupees Twenty-Seven Lakh Fifty-Two Thousand Five Hundred only) in 56 bundles of ₹500 denomination notes was recovered from the bedroom of Md. Ithem. Further, 39 (thirty nine) packets of suspected WY tablets which were kept inside a cardboard box was also recovered. On conventional weighing, the total weight was found to be approximately 879 grams in total (including the weight of plastic packets). Further, one Redmi Note 14Pro+ 5G mobile phone (IMEI1: 865267063147077/78 and IMEI2: 865267063147085/78) along with one AIRTEL sim card bearing no. 9383089877 and one JIO sim card bearing no. 9366031185 was also recovered. Accordingly, the above 39 (thirty nine) packets of suspected WY tablets, cash which are believed to be proceeds for the sale/purchase of narcotic substances and mobile phone were seized from the possession of Md. Ithem Khan at 0205 hrs. Accordingly, he was arrested by observing formalities at 0210 hrs. During the search operation at the residence of Raju Khan @ Chaoren S/o Shamu Khan of Khomidok Sorok Mapal cash amounting to ₹10,50,000/- (Rupees Ten Lakh Fifty Thousand only) in 16 bundles of ₹500 denomination, 10 bundles of ₹200 denomination, and 5 bundles of ₹100 denomination notes was detected.

Further, 50 (fifty) packets of suspected WY tablets which were kept concealed at his kitchen garden was recovered. On conventional weighing, the total weight was found to be approximately 1.125 kg in total (including the weight of plastic packets). Further, one Redmi Note 12 Pro 5G mobile phone (IMEI1:868358076549149 and IMEI2: 868358076549156) along with one AIRTEL sim card bearing no. 9233102313 and one JIO sim card bearing no. 9863575790 was also recovered. Accordingly, the recovered contraband items, cash which are believed to be proceeds for the sale/purchase of narcotic substances and mobile phone were seized from the possession of Raju Khan at 02:15 hrs. Accordingly, he was arrested by observing formalities at 02:20 hrs. Hence the case.

Further, 50 (fifty) packets of suspected WY tablets which were kept concealed at his kitchen garden was recovered. On conventional weighing, the total weight was found to be approximately 1.125 kg in total (including the weight of plastic packets). Further, one Redmi Note 12 Pro 5G mobile phone (IMEI1:868358076549149 and IMEI2: 868358076549156) along with one AIRTEL sim card bearing no. 9233102313 and one JIO sim card bearing no. 9863575790 was also recovered. Accordingly, the recovered contraband items, cash which are believed to be proceeds for the sale/purchase of narcotic substances and mobile phone were seized from the possession of Raju Khan at 0215 hrs.

Accordingly, he was arrested by observing formalities at 02:20 hrs.
