Subject:- Prayer to request for help and legal action regarding my relationship and sexual assault by Sapam Priyobarta Singh

Respected Medam/Sir,

I, Moirangthem Shanti Devi, aged 23 years, daughter of Moirangthem Tomba Singh, resident of Nachou Awang Leikai, (Name change) respectfully submit this application for your kind intervention and necessary legal action against Sapam Priyobarta Singh S/o. Sapam Subon Singh and Sapam Ongbi promila Devi, resident of Ningthoukhong Kha Khunou, Bishnupur, Manipur.

1. I came to know Sapam Priyobarta Singh in the year 2021 during my stay at Covid Quarantine Centre at Ningthoukhong Modern School and he start asking about me but at that time I again and again avoid him but he always follow me in my college and asked about me in my friends and even touch my feet to fell in love with him and I also believing him I developed a relationship with him. at 19/07/2022 he promised to marry me and asked me that if I did not come out he will die by consuming poison and I feel afraid and came out of my house and asked him not to do such act as my mother had just pass away and her rituals had not ended yet but he forced me to elope with him without my consent and I went with him and went to Cachar, Silchar (Assam) and stay there for like around 5 days in which he had sexual relationship again and again without my consent.
2. At Cachar, we stayed together as husband and wife and had sexual relations again and again without my consent on the basis of his promise to marry me and he also capture my phone and I was not allowed to hold my phone there. I don't have anyone known in that far away place so I feel afraid that I might be kill and thrown away somewhere so I obey him even when he force me to have sexual relation with me. And we also executed an affidavit of marriage and performed marriage at Rongpur Kali Mandir, Silchar, Cachar on 22/07/2022. I have a copy of the said affidavit in my possession.
3. When my old aged father heard about my elope news, he fell unconscious and directly admitted to Hospital. In that very night my brother sent me news in my phone but I came to know the news the next morning when Sapam Priyobarta went out at market to get some items and I secretly hold my phone and look at the massage about my father. So I cry and touch his feet to let me go at my house to meet my sick father and we came back to Manipur after I cry so much to him.
4. During my stay at Cachar Assam a complain was raised at Bishnupur Police Station but when we came back from Assam at 25/07/2022 and directly went to the police station Bishnupur and we had said that we mutually agreed and got married at Cachar Assam because I am a women and O already had sexual relation with him and now what will I gain when I say I have not agreed about our marriage so I thought that its better to say I have consent of my own but the reality is I did not have any consent in anything in whatever we did.
5. After were separated and come back to our house and I continued to consider him as my husband. However, since then he has never taken me to his house as his wife, nor has he accepted me in front of his family or society. His family too never care about me and never try to take me in their house after the incident.
6. Whenever I requested him to take me to his home and live with me as husband and wife, he refused. Recently, when I again asked him to accept me as his wife , he told me that he will not stay with me and that I can do whatever I want. After that he blocked my phone number and stopped all contact with me. I try calling in the whatsapp and he pick up the call and scolded me by saying that not to disturb him again and again.
7. Further, one day in the month of 24th of October 2025 at around 10:00 pm, he came at my village Nachou during Playing of Sumang Leela which is at night, he asked me to come out so that we can talk,
I went outside to talk with him and forcibly capture me in his vehicle and had forced sexual intercourse with me against my will and without my consent. Due to this forced act, I suffered severe pain and injuries in my private parts. I also have some relevant photos of my injury. Even after causing injury, he showed no concern for my health and did not provide any help or support. I text again and again in the Whatsapp App and try to call him but there is no reply from his side. I even sent some photos of my injury even there is no reply from him.
8. Because of this I have stop my further studies because I feel shy to face society and one day I even try to do suicide but thinking of my old father I had stop that wrong decision.

9. Till now I am waiting for him and his family to take me to their home but they did not and I don't have any means to contact with him anymore because his family members had blocked all my family members contact so that I could not contact with him anymore. He rape me again and again without my consent and now I am the only person who is suffering mentally and physically.

His conduct amounts to cheating, criminal breach of trust, and sexual assault/rape, and has caused me serious physical and mental trauma. I am living in great distress and fear because of his behaviour.

Therefore, I humbly request you to:

- Kindly register my complaint and treat this as information of offences committed by Sapam Priyobarta Singh.
- Record my detailed statement through a women police officer and allow me to submit copies of the affidavit of marriage and any other supporting documents/evidence available with me.
- Take immediate legal action against Sapam Priyobarta Singh in accordance with law, including registering an FIR according to applicable laws relating to sexual assault and cheating, and ensure my safety and protection.

I am ready to cooperate fully with the investigation and to appear before the police whenever required. Kindly do the needful at the earliest in the interest of justice.
