Subject: Report.

Sir,

I have the honour to report that today i.e. the 30th April, 2025 at about 2:00 a.m. received an information from FGT (Field General Team) Imphal, BSF corroborated with our own intelligence about the concealment of a huge nos. of arms, ammunitions and explosives by unknown arms miscreants in general area of Heingangkhong and its surrounding area of Imphal East. Based on the said information, a combined team of CDO, Imphal-East District and 164 Bn. BSF under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops) Imphal East District rushed to the said area and conducted a searched operation in the general area of Heingangkhong and its surrounding area of Imphal East District at about 3:10 a.m.

During the search operation, found two nos. of sack bags suspected to be containing arms, ammunitions and explosives hidden in a bush at the eastern side paddy field of Heingangkhong, Imphal East. On opening the sack bags the undernoted arms, ammunitions and explosives were found and recovered;

1. 1(one) no. of .303 rifle marked as '9545' with magazine,
2. 1(one) no. of Sniper rifle marked as 54584 with magazine,
3. 1(one) no. of 9 mm SMG carbine marked as 'A5115' with magazine,
4. 1(one) no. .32 Pistol marked as 'COLT DUBLED EDOLE',
5. 1(one) no. of Lethod shell,
6. 3(three) nos. of No. 36 Hand grenade without Detonator,
7. 10(ten) nos. of .303 live ammunition,
8. 5 (five) nos. of 7.62 mm live ammunition,
9. 10(ten) nos. of 5.56 X30 mm live ammunition,
10. 7(seven) nos. of 5.56 mm live ammunition,
11. 8(eight) nos. of 9 mm live Ammunition,
12. 2(two) nos. of .32 live ammunition,
13. 5(five) nos. of .303 blank cartridge,
14. 4(four) nos. of Detonator,
15. 3(three) nos. of Anti riot Shell
16. 2(two) nos. of tube launching,
17. 2(two) nos. of INSAS rifle Magazine,
18. 2(two) nos. of Helmet,
19. 4(four) nos. of BP Plate and
20. 1(one) no. of rubber bullet.

Accordingly, the above recovered arms, ammunitions, explosives along with the two sack bags were seized at the spot i.e. eastern side paddy field of Heingangkhong, Imphal East at 3:40 a.m. by observing due formalities.

Thereafter, the seized items are being handed over to you for taking up further necessary legal procedures.
