Subject: Report.

Sir,

I am to report that today i.e. 05/10/2025 at around 1.35 am, received a reliable information regarding pre-arranged miscreants at Keinou Bazar area who were involved in extortion and threatening the vehicle plying on National Highway late night. Based on the information, I along with my team under the command of Inspt. Y. Motilal Singh, OC under the supervision of Shri Amarjit Singh Lamabam, MPS, Addl. SP(Ops)/BPR and under the overall guidance of Shri Ravikumar Singh, IPS, SP-Bishnupur immediately rushed to the said area and conducted searched.

During the course of searched, two unknown individual were detained on suspicion at Keinou Bazar. After verification, they identified themselves as (1) Sarangthem Dinesh Singh (29) S/O (1) S. Tomba Singh of Keinou Bazar, ward no. 2 and (2) Khundrakpam Mohen Singh (25) S/O Kh. Rojit Singh of Keinou Thongthak Mamekhun. During examination, they disclosed that, they are involved in extortion and threatening to the vehicles plying on the N.H. 3-4 times earlier using one Bullet (two wheeler) without number plate. So, they were arrested from the spot at 1.45 am respectively. On further searching the said Bullet Classic 350 black in colour bearing Regd. No. nil was also seized from the roadside and seized at 1.58 am along with one Redmi Note 9 mobile phone dark blue in colour having one SIM card bearing mobile no. 8974560047 from the possession of Sarangthem Dinesh Singh by observing proper formalities.

Hence, the arrested persons along with the seized items are handed over to you for taking further necessary action against him.
