Subject Report.

Sir,

I have the honour to report that today i.e., 09/12/2025 at around 5.00 am, while I along with my team were conducting normal patrolling within the jurisdiction of Imphal-PS, three unknown persons were found loitering near Medical Directorate Office, Lamphelpat (opposite RIMS main gate). Due to their suspicious nature, our patrol team signalled them to stop at the spot, but on seeing the Police one of them escaped from the spot very swiftly. Further, the two unknown persons were detained for checking and verification. On verification, they identified themselves as - 1) Md. Milan (27yrs.) S/o Md. Salim of Golapati Maning Leikai and 2) Md. Serajun (27) S/o Md. Bahudar of Borayangbi, BPR District A/P- New Checkon, Imphal East. On checking their scooter Dio B/Regd. No. MN06SF-2562, found two master keys (T-shape screw drivers with blue handle with the marking "Taparia") in their scooter toolbox which is used for lifting vehicles. On further examination, they disclosed that they are vehicle lifters and they came at Medical Directorate Office, Lamphelpat along with the absconded person in their scooter Dio to steal vehicles. So, the two detainees were brought to PS for further necessary actions.

It is therefore, requested kindly to book the detained persons as per law.
