12. First Information contents:

Today, i.e., on 20/10/2025 at about 9:25 PM, reliable information was received that a group of youths had gathered at Ningthoukhong Ward No. 14, IVR area and were engaged in playing illegal dice games, thereby causing disturbance to public peace and tranquillity in the locality.

Accordingly, a police team led by SI Joykumar Singh of Bishnupur Police Station was immediately deputed to the spot to control the situation and disperse the unlawful gathering. Upon arrival, the unknown youths involved in the illegal gambling activities, along with several local supporters, turned hostile and violently attacked the police team and the police vehicle. The mob resorted to pelting stones and physically assaulting the personnel on duty, thereby creating a highly tense and volatile situation.

In order to disperse the mob, there was some tussle between the police and the mob. In that one VIB personnel, No. 0852 RK.Ranjitsana of Bishnupur Police Station, sustained injuries after being assaulted and was subsequently evacuated to the hospital for necessary medical treatment. In the course of the attack, the front wind shield glass of Q-73 of CDO/BPR vehicle was also damaged.

Due to the unruly behaviour of the mob and the disturbances caused by the gathering, videography of the incident could not be captured. There was considerable scuffle and confrontation between the police and the mob in the effort to disperse the mob and restore order.

Hence, a suo moto case has been registered under FIR No. 43(10)2025 BPR-PS at 118(2)/132/133/190/191(2)/324(3)/351(2)/3(5) BNS, 2023 and Section 3 & 4 of Public Gambling Act 1867 for further investigation.
