Sir,

I have the honour to report that today i.e. 18/11/2025 at around 5:00am, received a reliable input from 2 JAKLI corroborated with our own source regarding hide out of some arms and ammunitions suspected to be concealed by some unknown arm miscreants at Nachou Kha Mamang area. Immediately after coordination, a joint cordon and search operation was launched by a combined team of CDO/BPR led by self and assisted by ASI M. Inaotomba Singh and HC Y. Shanta Singh of CDO-BPR, a column of 2 JAKLI led by Lt. Shivam Pandey, team of Bishnupur Police station led by SI T. Joykumar Singh along with Executive Magistrate, Bishnupur, under the command of Inspt. Y. Motilal Singh, OC/CDO-BPR under the supervision of D. Robinson, DySP CDO II BPR and under the overall guidance of Shri Th. Shangkar Deba, MPS, SP-Bishnupur. During the course of cordon and search operation, the joint team successfully recovered the undernoted incriminating articles from Nachou Kha Mamang Patton which were kept concealed inside a rubber tube and one gunny sack.
