FIR Contents :- Today i.e. 04/09/2025 at 04:00 pm, a house to house CASO (Cordoned and searched operation) was conducted at Khomidok Karong Turel Mapal, Heingang PS/IE led by me along with personnel of A/68 Bn. SSB station at HNG-PS- IE, teams of Heingang PS- IE, OSCAR-15 of CDO-IE Unit, OSCAR-12 of CDO-IE Unit, teams of 86th Bn CRPF-Lamphel led by Shri K. Rajiv, Deputy Commandant & W. Nandini Devi, 2 i/c (Ops) and a team of Anti Narcotics Tasks Force (ANTF). That, during the search at the residence of one Mariyam Begum (54) D/o Md. Wahid of Khomidok Karong Turel Mapal, IE, the following illegal drugs suspected to be Heroin No. 4 powder among others i.e. (1) 13 Nos. of small vial containing suspected to be Heroin No.4 (2) 22 (twenty two) Nos. of empty transparent small vial (use in selling illegal No. 4 drugs) (3) One Oppo mobile Phone-Model No. CPH2471 along with one airtel sim card having No. 8413833622 (4) one Samsung mobile phone purple in colour (5) one Redmi mobile phone green in colour (6) one Redmi mobile phone black in colour (7) One Jio mobile phone black in colour and (8) a sum of Rs. 1,00,380/- (One lakhs three hundred and eighty) were seized from her possession at 05:45 pm. Accordingly, she was arrested from her residence at 05:46 pm.

That, on conventional weighing of all the seized illegal drugs it is found to be 16 grams including the weight of the small plastic vial.

Further, in continuation of the search operation at the house of one Abdul Matalib (36) yrs S/o Md. Jayauddin of Khomidok Karong Thong, IE and the following illegal drugs suspected to be Heroin No. 4 powder among others i.e. (1) 91 (ninety one) Nos. of small vial containing suspected to be Heroin No.4 (2) 115 Nos. of empty transparent small vial (use in selling illegal No. 4 drugs) (3) 14 Nos. of Syringe (4) one Samsung Note 20 Altra mobile handset (5) a sum of Rs. 23,370/- (Twenty three thousand three hundred seventy) were seized from his possession at 06:02. Accordingly, he was arrested from his residence at 06:03 pm.

That, on conventional weighing of all the seized illegal drugs it is found to be 113 grams including the weight of the small plastic vial.

On spot interrogation, Abdul Matalib disclosed that his younger brother namely Md. Umar (28) yrs S/o Late Md. Jayaoddin of Khomidok Karong Thong, IE and his sister In- law namely Ruhina (30) yrs W/o Md. Akbar of Khomidok Karong Thong, IE have full knowledge of the seized suspected Heroin No. 4 that was kept concealed in their house. Subsequently, arrested Md. Umar & Ruhina at 06:10 pm and 06:15 pm respectively.

Hence, a regular case has been registered under FIR No. 85(09)2025 HNG-PS u/s 21(b)/25 ND&PS Act for investigation.
