Rajib Khan, In-Charge Cyber Lab, Imphal East District, regarding an information about the movement of some drug traffickers in and around the Khabam Lamkhai area, a source report is submitted to Shri AK. Sadananda Singh, Addl. SP TCP/IE (Nodal ANTF) for executing the information into action. On approval of the source report, a joint team comprising Cyber Lab personnel, assisted by a CDO/IE team, was immediately dispatched for lookout and patrolling under the command of Inspector Md. Rajib Khan, In-Charge Cyber Lab, Imphal East, and under the supervision of AK. Sadananda Singh, Addl. SP TCP/IE (Nodal ANTF) and Shri Y. Joyraj Singh, Addl. SP (Ops) IE. At about 01:40 pm, the combined team intercepted two persons carrying four (04) large suitcases at Khabam Lamkhai (western side of the National Highway, near "Day and Night Koffee Korner"), Imphal East, suspiciously. Upon being stopped, we identified ourselves as Police Personnel of Imphal East. They were briefly questioned about the contents of the suitcases, and the two persons reluctantly admitted that the suitcases contained Cannabis/Ganja. The two persons were identified as: **Pathan Azaman Khan (19) S/o. Pathan Ayub Khan of Khomidok Masjid Maning, Imphal East**, who was in possession of 2 suitcases (brown and light sky-blue color). **Arjun Chingakham (19) S/o. Ch. Ibohanbi of Kongpal Khaideem Leikai, A/p- Khurai Kongpal Chingangbam Leikai, Imphal East**, who was in possession of 2 suitcases (Dark grey and black color). At the spot, I gave option for search to them giving option to be searched them in the presence of a Gazetted Officer or magistrate or two independent witnesses in which they have given their option to be searched in the presence of a Gazetted officer. Immediately, I informed senior officers, whereupon Miss. Reema Haobam, SDPO New Capitol Complex, Imphal East, arrived at the spot. In her presence and an independent witness, the suitcases were checked, and the following articles were found. The black colour suitcase (Marked as A) was found to contain 13 (thirteen) Nos. packets wrapped with transparent polythene containing suspected Cannabis/ Ganja and on conventional weighing it was found to be about 16 kg while the dark grey colour suitcase (marked as B), on checking, was found to contain 11 (eleven) Nos. packets wrapped with transparent polythene containing suspected Cannabis/ Ganja and on conventional weighing it was found to be about 14 kg. Hence, the two suitcases and one i-phone 7+ (IMEI NO. 359160079899406) along with one airtel SIM

card bearing No. 8729949628 were seized from the possession of **Arjun Chingakham** at 2:25 pm and arrested him at 2:40 pm by observing necessary formalities. The light sky blue colour suitcase (marked as C), on checking, was found to contain 11 (eleven) Nos. packets wrapped with transparent polythene containing suspected Cannabis/ Ganja and on conventional weighing it was found to be about 15 kg, while the brown colour suitcase (marked as D) was found to contain 11 (eleven) Nos. packets wrapped with transparent polythene containing suspected Cannabis/ Ganja on conventional weighing it was found to be about 16 kg. The two suitcases were then seized from the possession of **Pathan Azaman Khan** at 2:50 pm and arrested him at 3:00 pm by observing necessary formalities. Hence the case.

Hence, a regular case has been registered under FIR No. 88(09)2025 HNG-PS u/s 20(b)(ii) (C) ND&PS Act for investigation.
