One Ningthoujam Thoiba Meetei (45 yrs.) S/o Hera of Zenhang Lamka, Churachandpur A/p Mantripukhri near IGAR South, Imphal East lodge a written reported to OC HNG-PS stating on 24/09/2024 at around 09:30 am, he left his house located at Mantripukhri near IGAR South and went to keep my shop at Uripok and his wife also went to visit a relief camp at Phubala while his children were attending school, he left his house under proper lock and key. Later, at around 11:00 am, one of his localities called him on phone and informed him about his house being on fire. He immediately rushed to his house and reached home at around 11:20 am and found that the fire had already been extinguished with the help of his localities. Later, on 28/09/2024 at around 9:00 am, upon checking the damages caused by the fire, the following gold articles i.e. (i) Necklace with stone (12 sans), (ii) Neck chain (9 sans), (iii) Neck chain (6 sans), (iv) earring with chain (6 sans), (v) ring (graha mapan 4 sans), (vi) ring (thabi maru 2 sans), (vii) ring (thabi maru 2 ½ sans), (viii) ring (Bombay peti 3 sans), (ix) ring with stone (city bus 1 sans), (x) chain machine made (4 ½ sans), (xi) pendent fish design (1 ½ sans), (xii) earring (leikang thambal 2 ½ sans), (xiii) earring (1/2 sans), (xiv) gold 3 pieces (2 sans) and Rs. 1,20,000/- (one lakh twenty thousand) in cash were found stolen. And the approximate value of the stolen articles are Rs. 12,00,000/- (twelve lakhs). I could not report the theft on time as he was not certain as the missing articles were actually stolen or misplaced during the breaking out of fire and its aftermath. I, the undersigned, have the honour to state that on 24/09/2024 at around 09:30 pm, I left my house located at Mantripukhri near IGAR South and went to keep my shop at Uripok and my wife also went to visit a relief camp at Phubala while my children were attending school, I left my house under proper lock and key. Later, at around 11:00 am, one of my localities called me on phone and informed me about my house being on fire.
