Based on the said information and with the permission/authorization of the authority, teams of CDO/IE Unit conducted a C.I. Ops. at the said area under the command of Shri. Khumanthem Dhiraj Karan, MPS, Dy. SP(Ops)IE also looking after the charge of OC-CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops)IE at 9:00 a.m. In that, one unknown suspicious person was detained for spot verification and checking at northern side of Khurai Chairen Thong, Imphal East District. On checking the detainee body, one mobile phone was found and recovered from his possession. On spot verification, the detainee identified himself as one; Md. Tajuddin Shah @ Baboy (37) S/o (L) Md. Safijuddin Shah of Kshetri Awarf Leikai, Prompat PS, Imphal-East, A/p-Khabeisoi 7 MR Gate, Heingang PS, Imphal East District. On further verification, the detainee stated that he is an active member of the outfit KCP (PWG) joined through one Mr. Amit of KCP (PWG) group in the month of July, 2024 and got his basic military training with allotted army no. 249 of 2024 batched for 40 days under the command of one Mr. Boinao of KCP (PWG). The detainee further stated that he is presently working under the command of one Mr. John Moirangcha of KCP (PWG). So, the detainee was arrested from the spot i.e. northern side of Khurai Chairen Thong, Imphal East District at 12:25 p.m. and seized one mobile phone (Vivo V2029) bearing IMEI no. 865752050814334 & 865752050814326 along with one Jio SIM card having phone no. +91 8787 788710 from his possession at the spot i.e. northern side of Khurai Chairen Thong, Imphal East District at 12:30 p.m. by observing due formalities. Hence the case.
